ORDER

WHEREAS, in exercise of the powers conferred by sub-section (2) of Section 32 of the National Council for Teacher Education Act, 1993 (73 of 1993) and in supersession of the National Council for Teacher Education (Recognition Norms and Procedure) Regulations, 2009, the National Council for Teacher Education has notified the Regulations, 2014 on 01.12.2014.

- 2. AND WHEREAS, the institution Yaduvanshi College of Education, Khasra No. 180, Khatoni No. 232, Khasra No. 179, Khatoni NO. 231, VPO- Patikara, Tehsil- Narnaul, Mahendergarh, Haryana hasbeen recognized by NRC vide its Order No. NRC/NCTE/HR-998/870-76 dated 29.11.2010 for additional intake of 100 in the existing B.Ed course, thereby making the total annual intake of the institution to 200 seats.
- 3. AND WHEREAS, the institution has by affidavit consented to come under New Regulations and sought for two basic units in B.Ed., which requires additional facilities.
- 4. AND WHEREAS, it has been decided to permit the institution to have two basic units of 50 students each subject to the institution fulfilling following conditions namely.
 - The institution shall create additional facilities that include (a) additional built-up-area, (b) additional infrastructure, (c) additional funds, (d) adhere to staff norms as per Regulations, 2014 and inform Regional Committees with required documents by October 31, 2015.
 - The application-Institution for additional unit will be required to submit the required documents such as land documents, Encumbrance Certificate (EC), Land Use Certificate (LUC) and the Building Plan (BP) in the specified proforma available on the website to the Regional Committee in proof of having provided additional facilities before October 31, 2015. Building completion Certificate (BCC) may be given along with other documents if available, otherwise it can also be given to the Visiting Team at the time of inspection.
 - (iii) The Regional Committees shall arrange for verification of documents, inspection of these premises and check adherence to these condition by 20 February, 2016. If it is found by the Regional Committee that the institution fails to comply with these requirements, the institutions shall not be permitted to admit students for the academic year 2016-2017.
 - In case any existing institution's matter is sub-judice under court direction/SCN under section 17 of the NCTE Act/ Complaint etc., the institution shall be required to submit a copy of the Hon'ble Court order/reply to SCN/complaint/already submitted alongwith the documents, if any together the documents referred above. In case the institution's request for shifting of premises is pending, such institution shall be required to submit the requisite documents as per provisions of the NCTE Regulations, 2014 with a copy of the order/NOC of the affiliating body/State Govt. and such other documents as indicated in the revised format recognition order. The final decision shall be subject to the directions given by the Hon'ble Court in the Writ Petition/case decided by the Northern Regional Committee in respect of Section 17/complaint cases etc.
- Now therefore, in the light of the above, the Northern Regional Committee, NCTE hereby issues the revised Recognition Order to Yaduvanshi College of Education, Khasra No. 180, Khatoni No. 232, Khasra No. 179, Khatoni No. 231, VPO- Patikara, Tehsil- Narnaul, Mahendergarh, Haryana for conducting B.Ed. programme of Two years duration with an annual intake of 100 for two basic units of 50 students each from the academic session 2015-2016 subject to fulfillment of the conditions mentioned herein before 31.10.2015.

- 6. Further, the recognition is subject to fulfillment of other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.
- 7. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 8. The institution shall maintain & update its website as per provisions of NCTE Regulations and always display following as mandatory disclosure.
 - (a) Sanctioned programmes along with annual intake in the institution.
 - (b) Name of the faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
 - (c) Name of faculty members who left of joined during the last quarter.
 - Names of students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.
 - (e) Fee charged from students.
 - (f) Available infrastructural facilities.
 - (g) Facilities added during the last quarter.
 - (h) Number of books in the library, journals subscribed to and additions, if any, in the last quarter.
 - (i) The affidavit with enclosure submitted along with application.
 - (j) The institution shall be free to post additional relevant information, if is so desires.
 - (k) Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

If the institution Contravenes any the above conditions or the provision of the NCTE Act, Rules, Regulations and Orders made and issued there under, the institution will render itself liable to adverse action including withdrawal of recognition by the Regional Committee under the provisions of Section 17(1) of the NCTE Act.

ORDER

WHEREAS in terms of Section 15(1) of the NCTE Act, 1993 Yaduvanshi College of Education, VPO- Patikara, Tehsil- Narnaul, Mahendergarh, Haryana (HR-998) had submitted an application to the Northern Regional Committee of NCTE for grant of recognition/permission for starting B.Ed. Add. intake of one year duration with an annual Addl. intake of 100 (One Hundred only) students on 05.10.2007.

- 2. AND WHEREAS, the matter was placed in 139th Northern Regional Committee Meeting held from 10th 12th April, 2009 and the Committee decided to ask the institution to submit the legally valid documents as per regulation related with certain points within 21 days. Accordingly a letter was issued on 06.05.2009.
- AND WHEREAS, the matter was placed in 141st Northern Regional Committee Meeting held from 22nd to 24th May, 2009 and the Committee decided to constitute the VT. Further, the Institution is directed to obtain CLU as per clarification to be given by State Government of Haryana and recognition will be decided accordingly. Accordingly a letter was issued on 10.06.2009.
- AND WHEREAS, the inspection conducted U/s 15 on 19.06.2009 was placed in 143rd Northern Regional Committee Meeting held from 27th to 29th June, 2009 and the Committee decided to issue Show Cause Notice on certain points. Accordingly Show Cause Notice was issued on 07.07.2009.
- AND WHEREAS, the matter was placed in 146th Northern Regional Committee Meeting held from 5th to 7th August, 2009 and the Committee decided to refuse recognition for B.Ed. Add. Course. Accordingly an order was issued on 17.08.2009.
- AND WHEREAS, the institution preferred an appeal dated 11.11.2009 to the Council and the Council remand back the case to NRC for issuance of Letter of Intent prior to grant of recognition under Clause 7(9) of NCTE Regulations, 2007. The institution shall comply with the NAAC requirement as per regulations by April 2010. The matter was placed in 157th Northern Regional Committee Meeting held 24th to 27th March, 2010 and As per appeal committee decision, the Institute is directed to submit NAAC certificate by April 2010 for necessary action. Accordingly a letter was issued on 13.04.2010.
- AND WHEREAS, the matter was placed in 163rd Northern Regional Committee Meeting held from 29th to 31st July, 2010 and the Committee decided to issue Show Cause Notice. Accordingly a show Cause Notice issued on 18.08.2010.
- AND WHEREAS, the matter was placed in 169th Northern Regional Committee Meeting held from 12th -13th October, 2010 and the Committee decided that Letter of Intent Prior to Recognition under clause 7(9) be issued for 100 additional seats in B. Ed. Course. Accordingly Letter of Intent Prior to Recognition under clause 7(9) was issued on 22.10.2010.
- AND WHEREAS, the reply was placed in 172nd Northern Regional Committee Meeting held from 12th - 13th November, 2010 and the reply of the institution dated 01.11.2010 has been considered and found satisfactory. Hence, recognition order under section 7(11) of NCTE Regulations 2009 and 14(3)(a) of NCTE Act 1993 for B.Ed. course with an annual intake of 100 seats from the academic session 2010-
- NOW THEREFORE, in exercise of the powers vested under Section 15(3) (a) of the NCTE Act, 1993, the Northern Regional Committee hereby grants recognition to Yaduvanshi College of Education, VPO-Patikara, Tehsil- Narnaul, Mahendergarh, Haryana (HR-998) for B.Ed. Addl. Intake of one year duration with an annual intake of 100 + 100 = 200 Students (Two Hundred) under clause 7(11) of NCTE Regulations from the academic session 2010-2011 subject to the following conditions:-
 - (i) The admissions of students shall be made only after affiliation by the examining body before the commencement of the academic session and the admission of the students shall be completed well before the cut off date prescribed by the examining body for the academic session 2010-2011 failing which the recognition will be effective from the academic session 2011-2012.

- Formal order for recognition/permission will operate for 2010-2011 only if the requirement of 180 teaching days in the session is fulfilled as per calendar of the University/Affiliating Body failing which the recognition will be effective from the academic session 2011-2012.
- The institution shall, within one month of the receipt of recognition order, convert the endowment (iii) fund and reserve fund in the joint name of an authorized representative of the management and the Regional Director, Northern Regional Committee.
- The institution shall comply with the various other norms and standards prescribed in the NCTE (iv) regulations, as amended from time to time.
- The institution shall make admission only after it obtains affiliation from the examining body in (v) terms of clause 8(12) of the NCTE Regulations.

- The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant together with statement of T.D.S. in respect of the salary paid to the staff. A copy of the format is enclosed with the order.
- If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as stipulated provisions of Section 17(1) of the NCTE Act.
- The institution shall maintain & update its Web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure: -
 - Copy of the Application Form
 - Land and Building Particulars
 - Staff Profile
 - Recognition letter

Information for having fulfilled the norms & standard and other required conditions.

In case if the land is in the name of the Society, the institution must transfer the land within six month in the name of the institution failing to which action shall be initiated to withdraw the recognition. It shall be essential on the part of the institution concerned to get the needful done in this regard and intimate the respective Regional Committee along with the new land document within the stipulated time.
