ORDER

WHEREAS, in exercise of the powers conferred by sub-section (2) of Section 32 of the National Council for Teacher Education Act, 1993 (73 of 1993) and in supersession of the National Council for Teacher Education (Recognition Norms and Procedure) Regulations, 2009, the National Council for Teacher Education has notified the Regulations, 2014 on 01.12.2014.

- 2. AND WHEREAS, the institution Sita Ram Arya Memorial College of Education, Khasra No. 11/6 Min, Khatoni No. 20, Murabba No. 106, Killa No. 13, (8-0), 14 (8-0), 15/1 (7-2), Kila No. 17 (8-0), 18 (8-0), 19/1 (5-8), 22/2 (2-12), 23 (8-0), Murabba No. 114 Killa-No. 3 (7-16), Vill-Bherian, P.o-Muklan, Rajgarh Road, Distt-Hissar, Haryana has been recognized by NRC vide its Order No. NRC/NCTE/F-7/HR-1347/11080-86 dated 06.10.2009 for B.Ed. course with an annual intake of 100 seats.
- AND WHEREAS, the institution has by affidavit consented to come under New Regulations and sought for two basic units in B.Ed., which requires additional facilities.
- AND WHEREAS, it has been decided to permit the institution to have two basic units of 50 students each subject to the institution fulfilling following conditions namely.
 - The institution shall create additional facilities that include (a) additional built-up-area, (b) additional infrastructure, (c) additional funds, (d) adhere to staff norms as per Regulations, 2014 and inform Regional Committees with required documents by October 31, 2015.
 - The application-Institution for additional unit will be required to submit the required documents such as (ii) land documents, Encumbrance Certificate (EC), Land Use Certificate (LUC) and the Building Plan (BP) in the specified proforma available on the website to the Regional Committee in proof of having provided additional facilities before October 31, 2015. Building completion Certificate (BCC) may be given along with other documents if available, otherwise it can also be given to the Visiting Team at the time of inspection.
 - (iii) The Regional Committees shall arrange for verification of documents, inspection of these premises and check adherence to these condition by 20 February, 2016. If it is found by the Regional Committee that the institution fails to comply with these requirements, the institutions shall not be permitted to admit students for the academic year 2016-2017.
 - In case any existing institution's matter is sub-judice under court direction/SCN under section 17 of the (iv) NCTE Act/ Complaint etc., the institution shall be required to submit a copy of the Hon'ble Court order/reply to SCN/complaint/already submitted alongwith the documents, if any together the documents referred above. In case the institution's request for shifting of premises is pending, such institution shall be required to submit the requisite documents as per provisions of the NCTE Regulations, 2014 with a copy of the order/NOC of the affiliating body/State Govt, and such other documents as indicated in the revised format recognition order. The final decision shall be subject to the directions given by the Hon'ble Court in the Writ Petition/case decided by the Northern Regional Committee in respect of Section 17/complaint cases etc.
- Now therefore, in the light of the above, the Northern Regional Committee, NCTE hereby issues the revised Recognition Order to Sita Ram Arya Memorial College of Education, Khasra No. 11/6 Min, Khatoni No. 20, Murabba No. 106, Killa No. 13, (8-0), 14 (8-0), 15/1 (7-2), Kila No. 17 (8-0), 18 (8-0), 19/1 (5-8), 22/2 (2-12), 23 (8-0), Murabba No. 114 Killa No. 3 (7-16), Vill- Bherian, P.o. Muklan, Rajgarh Road, Distt- Hissar, Haryana for conducting B.Ed.

- 6. Further, the recognition is subject to fulfillment of other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.
- 7. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 8. The institution shall maintain & update its website as per provisions of NCTE Regulations and always display following as mandatory disclosure.
 - (a) Sanctioned programmes along with annual intake in the institution.
 - (b) Name of the faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
 - (c) Name of faculty members who left of joined during the last quarter.
 - (d) Names of students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.
 - (e) Fee charged from students:
 - (f) Available infrastructural facilities.
 - (g) Facilities added during the last quarter.
 - (h) Number of books in the library, journals subscribed to and additions, if any, in the last quarter.
 - (i) The affidavit with enclosure submitted along with application.
 - (j) The institution shall be free to post additional relevant information, if is so desires.
 - (k) Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

Orders made and issued there under, the institution will render itself liable to adverse action including withdrawal of recognition by the Regional Committee under the provisions of Section 17(1) of the NCTE Act.

WHEREAS in terms of Section 14(1) of the NCTE Act, 1993 SITARAM ARYA MEMORIAL COLLEGE OF EDUCATION, VILL — BHERIAN, POST — MUKLAN, RAJGARH ROAD, DISTT. — HISSAR, HARYANA has submitted an application (code No. APN06211) to the Northern Regional Committee of NCTE for grant of recognition/permission for starting B.Ed. course of One year duration with an annual intake of 100 (one Hundred) students on 31.12.2007.

- 2. - NOW, THEREFORE, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993, the Northern Regional Committee hereby grants recognition/permission to 1993 SITARAM ARYA MEMORIAL COLLEGE OF EDUCATION, VILL BHERIAN, POST MUKLAN, RAJGARH ROAD, DISTT. HISSAR, HARYANA for conducting B.Ed. Course of Secondary (level) of one year duration with an annual intake of 100 (One Hundred) students from the academic session 2009--2010 under clause 7(11) of NCTE Regulation, 2007 notified on 10-12-2007. This order is issued in compliance with the direction/order on Hon'ble High Court of Rajasthan at Jaipur Bench passed on 16.09.2009 in the S.B. Civil Writ Petition No. 11188 / 2009.
- 4. The institution shall, within one month of the receipt of recognition order, convert the endowment fund and reserve fund accounts into joint accounts to be operated along with an officer of the Northern Regional Committee.
- 5. The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
