WITHDRAWAL ORDER

WHEREAS the institution namely B.S. Anangpuria Institute of Technology & Management, Adampur, Ballabgrah- Sohna Road, Faridabad, Haryana-121004 was granted recognition vide NRC order No. F.NRC/NCTE/F-3/HR-181/2439 dated 28.05.2004 for B.Ed. course with an annual intake 100 students followed by Revised Recognition order No. NRC/NCTE/NRCAPP/HR-181/2015/103238-43 dated 23.05.2015 for an annual intake 100 students. The institution was also granted recognition for D.Ed. course by NRC vide order No.NRC/NCTE/F-3/HR-245/5467 dated-07.07.2005 with an annual intake 50 students.

AND, WHEREAS, the institution submitted the letters in NRC office on 04.08.2017, 08.08.2017 and 09.08.2017 requesting for withdrawal of recognition for B.Ed. & D.El.Ed. courses.

AND WHEREAS, the matter was considered by the NRC in its 274th meeting held from 29th to 31st August, 2017 and the Committee decided as under:-

NRC considered the letter dated 02.8.2017 signed by the Director of the institute with a request to close
the files for B.Ed. and D.El.Ed. courses. The applicant institution is directed to submit the request in the
form of an affidavit alongwith the Resolution of the Governing body of the College.

The institution be informed accordingly.

AND WHEREAS, a letter was issued to the institution on 05.09.2017.

AND WHEREAS, the reply dated 19.09.2017 submitted by the institution was considered by the NRC in its 275th meeting held from 16th to 21st September, 2017 and the Committee decided as under:-

Request dated 19.9.2017 for withdrawal of recognition for B.Ed. & D.El.Ed. courses accepted.

Hence, the Committee decided that the recognition granted to the institution for B.Ed. & D.El.Ed. courses is withdrawn u/s 17 of the NCTE Act, 1993 from the end of the academic session next following the date of order of withdrawal. FDRs, if any, be returned to the institution.

NOW THEREFORE, in exercise of the powers vested under Section 17 of the NCTE Act, 2014, the Northern Regional Committee hereby withdraws the recognition granted to the institution i.e B.S. Anangpuria Institute of Technology & Management, Adampur, Ballabgrah-Sohna Road, Faridabad, Haryana-121004 for B.Ed. & D.El.Ed. courses on the grounds mentioned above.

If the institution is not satisfied by the above order, it may prefer an appeal to the Council (NCTE, New Delhi) in terms of Section 18 of NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the issue of this order. WHEREAS, in exercise of the powers conferred by sub-section (2) of Section 32 of the National Council for Teacher Education Act, 1993 (73 of 1993) and in supersession of the National Council for Teacher Education (Recognition Norms and Procedure) Regulations, 2009, the National Council for Teacher Education has notified the Regulations, 2014 on 01.12.2014.

- AND WHEREAS, the institution i.e. B.S.Anangpuria Institute Of Technology & Managemen, Adampur, Ballabgarh, Sohna Road, Faridabad-121004 has been recognized for B.Ed course by NRC vide order No. F.NRC/ NCTE/F-3/HR-181/2439 dated 28th May 2004 with an annual intake of 100.
- AND WHEREAS, the institution has by affidavit consented to come under New Regulations and has sought for two basic units in B.Ed., which require additional facilities.
- 4. ___AND_WHEREAS, it has been decided to permit the institution to have two basic units of 50 students each, subject to the institution fulfilling the following conditions, namely:-
 - The institution shall create additional facilities that include (a) additional built-up-area, (b) additional (i) infrastructure, (c) additional funds, (d) adhere to staff norms as per Regulations, 2014 and inform Northern Regional Committee, with required documents by October 31, 2015.
 - The institution for additional unit will be required to submit the required documents such as, land (ii) documents, non-encumbrance Certificate (EC), Land Use Certificate (LUC) and the Building Plan (BP) in the specified proforma available on the website to the Regional Committee in proof of having provided additional facilities before October 31, 2015. Building completion Certificate (BCC) may be given along with other documents, if available, otherwise it can also be given to the Visiting Team at the time of inspection.
 - The Regional Committee shall arrange for verification of documents, inspection of these premises and (iii) check adherence to these conditions by 20 February, 2016. If it is found by the Regional Committee that the institution fails to comply with these requirements, the institution shall not be permitted to admit students for the academic year 2016-2017.
 - In case any existing institution's matter is sub-judice under court direction/SCN under section 17 of the NCTE Act/ Complaint etc., the institution shall be required to submit a copy of the Hon'ble Court order/reply to SCN/complaint/already submitted alongwith documents, if any, together with the documents referred above. In case the institution's request for shifting of premises is pending, such institution shall be required to submit the requisite documents as per provisions of the NCTE Regulations, 2014 with a copy of the order/NOC of the affiliating body/State Govt. and such other documents as indicated in the revised recognition order. The final decision shall be subject to the directions given by the Hon'ble Court in the Writ Petition/case decided by the Northern Regional Committee in respect of Section 17/complaint cases etc.
- Now therefore, in light of the above, the Northern Regional Committee, NCTE hereby issues the revised Recognition Order to. B.S. Anangpuria Institute Of Technology & Managemen, Adampur, Ballabgarh, Sohna Road, Faridabad-121004, for conducting B.Ed. programme of two years duration with an annual intake of 100 students, for two basic units of 50 students each, from the academic session 2015-2016 subject to fulfillment of the conditions mentioned herein before 31.10.2015.
- 6. --- Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by otherregulatory bodies like UGC, affiliating University/ Body, State Government etc. as applicable. The affiliating body

<u>ORDER</u>

B.S.Anangpuria Institute of Technology & Management, Adampur, Ballabgarh - Sohna Road, Faridabad - 121004, Haryana submitted an application to the Northern Regional Committee of National Council for Teacher Education for grant of recognition for <u>B.Ed. Course</u> of One Year duration in terms of section 14(1) of NCTE Act, 1993.

- 2. Now, therefore, in exercise of the powers vested under Section 14(3)(a) of the NCTE Act, 1993, the Regional Committee hereby grants recognition to B.S. Anangpuria Institute of Technology & Management, Adampur, Ballabgarh Sohna Road, Faridabad 121004, Haryana for an annual intake of 100 seats (One Hundred only) in B.Ed. Course of One year duration with effect from the academic session 2004-2005 subject to fulfillment of the following before the commencement of the session:
 - a. Appointment of the faculty members duly qualified and staff as per the norms of NCTE/ State Govt./UGC is to be completed before the commencement of the session.
 - b. The countersigned statement of all faculty members from the Registrar of the concerned University should be submitted before the commencement of the academic session 2004-2005.

c. The institution shall adhere to all the other regulations and guidelines as framed by NCTE from time to time.

d. The institution shall within one month of the receipt of Recognition order, convert the Endowment Fund account into a Joint Account in the form of FDR for a period of not less than 60 months (Five years) in a Nationalized Bank only to be operated along with an official of the Regional Committee.

- e. That the Reserve Fund for an amount equal to three months salary of the Teachers & Staff be created within one month from the date of issue of this order and maintained in the form of FDR in favour of the management/institution, for a period of not less than sixty months (Five
- f. Non-compliance of the above mentioned conditions shall cause action under section 17 (1) of NCTE Act, 1993.
- 3. The Recognition is subject to the condition that the affiliating University shall ensure that, among other things, the institution has appointed required number of faculty members (including Principal / Head of Department), as per the norms of the NCTE / UGC / Affiliating University.
- 4. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC and State Government, etc.
- 5. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with a copy of the approval of the affiliating University / State Directorate of Education about the appointment of faculty members and the Statement of Annual Accounts duly audited by a Chartered Accountant.
- 6. If the institution contravenes any of the above conditions or any of the provisions of the NCTE Act, Rules, Regulations and/or order made or issued there under, the Regional Committee may withdraw the recognition under the provisions of Section 17(1) of the NCTE Act, 1993.


