ORDER

WHEREAS, in exercise of the powers conferred by sub-section (2) of Section 32 of the National Council for Teacher Education Act, 1993 (73 of 1993) and in supersession of the National Council for Teacher Education (Recognition Norms and Procedure) Regulations, 2009, the National Council for Teacher Education has notified the Regulations, 2014 on 01.12.2014.

- 2. AND WHEREAS, the institution i.e. Sat Jinda Kalyana College of Education, Bhiwani Road, Kalanaur, Rohtak, Haryana has been recognized for B.Ed course by NRC vide order No. F.NRC/ NCTE/F-7/HR-335/Appeal Order 89-403/2010/26605 dated 16th August 2010 with an annual intake of 100 students.
- 3. **AND WHEREAS,** the institution has by affidavit consented to come under New Regulations and sought for two basic units in B.Ed., which requires additional facilities.
- 4. **AND WHEREAS,** it has been decided to permit the institution to have two basic units of 100 students subject to the institution fulfilling following conditions namely:-
 - (i) The institution shall create additional facilities that include (a) additional built-up-area, (b) additional infrastructure, (c)additional funds, (d) adhere to staff norms as per Regulations, 2014 and inform Regional Committees with required documents by October 31, 2015.
 - (ii) The application-Institution for additional unit will be required to submit the required documents such as land documents, Encumbrance Certificate (EC), Land Use Certificate (LUC) and the Building Plan (BP) in the specified proforma available on the website to the Regional Committee in proof of having provided additional facilities before October 31, 2015. Building completion Certificate (BCC) may be given along with other documents if available, otherwise it can also be given to the Visiting Team at the time of inspection.
 - (iii) The Regional Committees shall arrange for verification of documents, inspection of these premises and check adherence to these condition by 20 February, 2016. If it is found by the Regional Committee that the institution fails to comply with these requirements, the institutions shall not be permitted to admit students for the academic year 2016-2017.
 - (iv) In case any existing institution's matter is sub-judice under court direction/SCN under section 17 of the NCTE Act/ Complaint etc., the institution shall be required to submit a copy of the Hon'ble Court order/reply to SCN/complaint/already submitted alongwith the documents, if any together the documents referred above. In case the institution's request for shifting of premises is pending, such institution shall be required to submit the requisite documents as per provisions of the NCTE Regulations, 2014 with a copy of the order/NOC of the affiliating body/State Govt. and such other documents as indicated in the revised format recognition order. The final decision shall be subject to the directions given by the Hon'ble Court in the Writ Petition/case decided by the Northern Regional Committee in respect of Section 17/complaint cases etc.
- 5. Now therefore, in the light of the above, the Northern Regional Committee, NCTE hereby issues the revised Recognition Order to Sat Jinda Kalyana College of Education, Bhiwani Road, Kalanaur, Rohtak, Haryana for conducting B.Ed. programme of two years duration with an annual intake of 100 (|One hundred only) for two basic unit of 50 students from the academic session 2015-2016 subject to fulfillment of the conditions mentioned herein before 31.10.2015.

The institution shall be free to post additional relevant information, if is so desires. (j)

Any false or incomplete information on website shall render the institution liable for withdrawal of (k) recognition.

If the institution Contravenes any the above conditions or the provision of the NCTE Act, Rules, Regulations and Orders made and issued there under, the institution will render itself liable to adverse action including withdrawal of recognition by the Regional Committee under the provisions of Section 17(1) of the NCTE Act.



ORDER

WHEREAS **Sat Jinda Kalyana College of Education, Bhiwani Road, Kalanaur, Rohtak, Haryana** had submitted application for recognition **(HR-335)** of **B.Ed** course of one year (1) duration under section **14(1)** of the NCTE Act, 1993 to the Northern Regional Committee, NCTE on **30.12.2005**.

- 2. AND WHEREAS the competent authority had constituted a Visiting Team to visit the institution and the visiting team had since submitted its reports on **07.08.2006**
- 3. AND WHEREAS on scrutiny/perusal of the application submitted by the institution, the documents attached therewith, the affidavit and the input received from the visiting team in the form of report and videography, recommendation of the State Government, the Northern Regional Committee in its 107th (2nd sitting) Meeting held from 07th 09th September 2006 decided to grant conditional recognition to the institution vide NRC order dated 9th September 2006
- 4. AND WHEREAS the original file of the institution along with all other related documents, Act of NCTE, 1993, Regulations and Guidelines of NCTE issued from time to time were considered by the **Northern Regional Committee in its 159th Meeting held from 28th April to 01st May, 2010 and the committee observes the following:**
 - The deficiencies communicated to the Institution through letter number F.NRC/NCTE/F-3/HR-335/156 meeting / 2010/ 18710 dated 18 March 2010 still exist.
 - As per Institution reference number 13 dated 5 March 2010, it is evident that the Institution admitted students in B.Ed. programme without the approval of NCTE.
- 5. Hence, the committee decides to refuse recognition to B.Ed. programme and return FDRs if submitted.
- 6. NOW THEREFORE grant of recognition to **Sat Jinda Kalyana College of Education**, **Bhiwani Road**, **Kalanaur**, **Rohtak**, **Haryana** for the course in **B.Ed** in term of section **14(3)(b)** of the NCTE Act, 1993 is hereby **refused**.
- 7. If the institution is not satisfied by the above order they can prefer an appeal to the council in terms of sections 18 of NCTE Act, 1993.
