WHEREAS in terms of Section 14(1) of the NCTE Act, 1993 Pt. Ram Niwas Memorial College of Education, VPO-Nanwan, Mohindergarh, Haryana (HR-1713) had submitted an application to the Northern Regional Committee of NCTE for grant of recognition/permission for starting <u>B.Ed.</u> Course of <u>one year</u> duration with an annual intake of 100 (One Hundred only) students on 03.07.2008.

- 2. AND WHEREAS the inspection under section 14 was conducted on 07.10.2008. The matter was placed in Northern Regional Committee in its 137th Meeting held from 28th Feb., to 1st March, 2009 and as per decision of the Committee a Show Cause Notice was issued on 12.3.2009.
- 3. AND WHEREAS the matter was placed before the Northern Regional Committee in its 139th Meeting held from 10th to 12th April, 2009 and the Committee decided to refuse the recognition. Accordingly the order was issued on 23.4.2009.
- 4. AND WHEREAS the institution preferred an appeal against the said order on 25.9.2009. The Appellate Authority accepted the appeal and remand back the case to NRC for issuance of Letter of Intent rior to grant of recognition under clause 7(9) of NCTE Regulations, 2007. Accordingly the Letter of Intent Prior to Recognition was issued on 04.12.2009.
- 5. AND WHEREAS the matter was placed before the Northern Regional Committee in its 153rd Meeting held from 11th to 12th December, 2009 and as per decision of the Committee a Show Cause Notice was issued on 8.12.2009.
- 6. AND WHEREAS the matter was placed before the Northern Regional Committee in its 154th Meeting held from 9th to 11th January, 2010 and as per decision of the Committee a letter was issued to the institute n 21.1.2010.
- 7. AND WHEREAS the matter was placed before the Northern Regional Committee in its 159th Meeting held from 28th April to 1st May, 2010 and as per decision of the Committee a Letter of Intent Prior to Recognition under clause 7(9) was issued on 14.5.2010.
- 8. AND WHEREAS the matter was placed before the Northern Regional Committee in its 162nd Meeting held from 24th to 27th June, 2010 and as per decision of the Committee a Show Cause Notice was issued on 23.7.2010.
- 9. AND WHEREAS the matter was placed before the Northern Regional Committee in its 163rd Meeting held from 29th to 31st July, 2010 and the Committee decided to issue Show Cause Notice on the following point:-

- 14. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant together with statement of T.D.S. in respect of the salary paid to the staff. A copy of the format is enclosed with the order.
- 15. If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as stipulated provisions of Section 17(1) of the NCTE Act.
- 16. The institution shall maintain & update its Web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure: -
 - Copy of the Application Form
 - · Land and Building Particulars
 - Staff Profile
 - Recognition letter
 - Information for having fulfilled the norms & standard and other required conditions.

17. In case if the land is in the name of the Society, the institution must transfer the land within six month in the name of the institution failing to which action shall be initiated to withdraw the recognition. It shall be essential on the part of the institution concerned to get the needful done in this regard and intimate the respective Regional Committee along with the new land document within the stipulated time.

ORDER

WHEREAS, in exercise of the powers conferred by sub-section (2) of Section 32 of the National Council for Teacher Education Act, 1993 (73 of 1993) and in supersession of the National Council for Teacher Education (Recognition Norms and Procedure) Regulations, 2009, the National Council for Teacher Education has notified the Regulations, 2014 on 01.12.2014.

- AND WHEREAS, the institution Pt Ram Niwas Memorial College of Education, Khewat No. 175, Khatoni 2. NO. 323 to 325, VPO Nanwan, Mohindergarh, Haryana has been recognized by NRC vide its Order No. NRC/NCTE/F-7/ HR-1713/ 2010/166th Meeting/27783-89 dated 20th Sept 2010 for B.Ed. course for 100 seats.
- AND WHEREAS, the institution has by affidavit consented to come under New Regulations and sought for two basic units in B.Ed., which requires additional facilities.
- 4. AND WHEREAS, it has been decided to permit the institution to have two basic units of 50 students each subject to the institution fulfilling following conditions namely.
 - The institution shall create additional facilities that include (a) additional built-up-area, (b) additional (i) infrastructure, (c) additional funds, (d) adhere to staff norms as per Regulations, 2014 and inform Regional Committees with required documents by October 31, 2015.
 - The application-Institution for additional unit will be required to submit the required documents such as (ii) land documents, Encumbrance Certificate (EC), Land Use Certificate (LUC) and the Building Plan (BP) in the specified proforma available on the website to the Regional Committee in proof of having provided additional facilities before October 31, 2015. Building completion Certificate (BCC) may be given along with other documents if available, otherwise it can also be given to the Visiting Team at the time of inspection.
 - The Regional Committees shall arrange for verification of documents, inspection of these premises and (iii) check adherence to these condition by 20 February, 2016. If it is found by the Regional Committee that the institution fails to comply with these requirements, the institutions shall not be permitted to admit students for the academic year 2016-2017.
 - In case any existing institution's matter is sub-judice under court direction/SCN under section 17 of the (iv) NCTE Act/ Complaint etc., the institution shall be required to submit a copy of the Hon'ble Court order/reply to SCN/complaint/already submitted along with the documents, if any together the documents referred above. In case the institution's request for shifting of premises is pending, such institution shall be required to submit the requisite documents as per provisions of the NCTE Regulations, 2014 with a copy of the order/NOC of the affiliating body/State Govt, and such other documents as indicated in the revised format recognition order. The final decision shall be subject to the directions given by the Hon'ble Court in the Writ Petition/case decided by the Northern Regional Committee in respect of Section 17/complaint cases etc.
- Now therefore, in the light of the above, the Northern Regional Committee, NCTE hereby issues the revised Recognition Order to Pt Ram Niwas Memorial College of Education, Khewat No. 175, Khatoni NO. 323 to 325, VPO Nanwan, Mohindergarh, Haryana for conducting B.Ed. programme of two years duration with an annual intake of 100 for two basic units of 50 students each from the academic session 2015-2016 subject to fulfillment of the conditions mentioned herein before 31.10.2015.
