#### **ORDER**

WHEREAS, in exercise of the powers conferred by sub-section (2) of Section 32 of the National Council for Teacher Education Act, 1993 (73 of 1993) and in supersession of the National Council for Teacher Education (Recognition Norms and Procedure) Regulations, 2009, the National Council for Teacher Education has notified the Regulations, 2014 on 01.12.2014.

- AND WHEREAS, the institution i.e. Swaranjali College of Education, Devlawas, Bithwana Chowk, Post Chhuriawas, Bawal Road, Rewari - 123 401, Haryana has been recognized for M.Ed course by NRC vide order No. F.NRC/ NCTE/ F-7/HR-972/38664 dated 09th February 2008.
- AND WHEREAS, the institution has by affidavit consented to come under New Regulations and sought for one basic units in M.Ed., which requires additional facilities.
- AND WHEREAS, it has been decided to permit the institution to have one basic units of 50 students subject to the institution fulfilling following conditions namely:-
  - (i)\_ The institution shall create additional facilities that include (a) additional built-up-area, (b) additional infrastructure, (c)additional funds, (d) adhere to staff norms as per Regulations, 2014 and inform Regional Committees with required documents by October 31, 2015.
  - (ii) The application-Institution for additional unit will be required to submit the required documents such as land documents, Encumbrance Certificate (EC), Land Use Certificate (LUC) and the Building Plan (BP) in the specified proforma available on the website to the Regional Committee in proof of having provided additional facilities before October 31, 2015. Building completion Certificate (BCC) may be given along with other documents if available, otherwise it can also be given to the Visiting Team at the time of inspection.
  - (iii) The Regional Committees shall arrange for verification of documents, inspection of these premises and check adherence to these condition by 20 February, 2016. If it is found by the Regional Committee that the institution fails to comply with these requirements, the institutions shall not be permitted to admit students for the academic year 2016-2017.
  - (iv) In case any existing institution's matter is sub-judice under court direction/SCN under section 17 of the NCTE Act/ Complaint etc., the institution shall be required to submit a copy of the Hon'ble Court order/reply to SCN/complaint/already submitted along with the documents, if any together the documents referred above. In case the institution's request for shifting of premises is pending, such institution shall be required to submit the requisite documents as per provisions of the NCTE Regulations, 2014 with a copy of the order/NOC of the affiliating body/State Govt. and such other documents as indicated in the revised format recognition order. The final decision shall be subject to the directions given by the Hon'ble Court in the Writ Petition/case decided by the Northern Regional Committee in respect of Section 17/complaint cases etc.
- Now therefore, in the light of the above, the Northern Regional Committee, NCTE hereby issues the revised Recognition Order to Swaranjali College of Education, Devlawas, Bithwana Chowk, Post Chhuriawas, Bawal Road, Rewari - 123 401, Haryana for conducting M.Ed. programme of two years duration with an annual intake of 50 (Fifty

- 6. Further, the recognition is subject to fulfillment of other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.
- 7. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 8. The institution shall maintain & update its website as per provisions of NCTE Regulations and always display following as mandatory disclosure.

(a) Sanctioned programmes along with annual intake in the institution.

(b) Name of the faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.

(c) Name of faculty members who left of joined during the last quarter.

(d) Names of students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.

(e) Fee charged from students.

(f) Available infrastructural facilities.

(g) Facilities added during the last quarter.

(h) Number of books in the library, journals subscribed to and additions, if any, in the last quarter.

(i) The affidavit with enclosure submitted along with application.

(i) The institution shall be free to post additional relevant information, if is so desires.

(k) Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

If the institution Contravenes any the above conditions or the provision of the NCTE Act, Rules, Regulations and Orders made and issued there under, the institution will render itself liable to adverse action including withdrawal of recognition by the Regional Committee under the provisions of Section 17(1) of the NCTE Act.



ORDER

WHEREAS, Swaranjali College of Education, Devlawas, Bithwana Chowk, St-Chhuriawas Bawal Road, Rewari, Haryana was granted recognition for running M. Ed. Course of one year duration to Northern Regioinal Committee vide this office order number F.NRC/NCTE/F-7/HR-972/38659-65 dated 09.02.2008

AND WHEREAS the recognition of the institution was withdrawn by NRC in its 163rd meeting held form 29th to 31st July, 2010.

AND WHEREAS, the appellant filed the statutory appeal to the council also filed a writ petition WP© 5443/2010 & C.M. No. 10715/20109(for stay) before the Hon'ble High Court of Delhi at New Delhi fearing loss of admissions for the current academic year. The Hon'ble Court in their order dt.12.08.10 stayed the order of the NRC and directed the Council to decide the appeal within three weeks (from the date of the order).

AND WHEREAS the institution preferred an appeal to the Appellate Authority against the NRC decision taken about this institution vide minutes of NRC meeting held on 29th to 31st July, 2010 and the council after perusal of documents, memorandum of appeal, affidavit, and after Considering oral arguments advanced during the hearing, the Council reached the conclusion that there was adequate ground to accept the appeal and set-aside NRC's decision taken about this institution vide minutes of NRC meeting held on 29th July to 31st July, 2010. Accordingly the minutes of NRC in respect of above institution was set-aside with direction to the NRC to restore recoginition for B.Ed and M.Ed. Course.

AND WHEREAS the matter was considered in 166th NRC meeting held on 09th Sept, 2010 and the Committee decided as under:
