**ORDER**

**WHEREAS**, in exercise of the powers conferred by sub-section (2) of Section 32 of the National Council for Teacher Education Act, 1993 (73 of 1993) and in supersession of the National Council for Teacher Education (Recognition Norms and Procedure) Regulations, 2009, the National Council for Teacher Education has notified the Regulations, 2014 on 01.12.2014.

2. **AND WHEREAS**, the institution **Saraswati College of Education, Khewat No. 723 Min/690, Khatoni No. 779 Min, Rect No. 29, Killa No. 20, 21, 22, Rect No. 46, Killa No. 1/2, 2, Kawi Road, Madlauda, Panipat, Haryana** was recognized by NRC vide its Order No. NRC/NCTE/F-7/HR-1108/21354 dated 05.05.2010 for M.Ed. course.

3. **AND WHEREAS**, the institution has by affidavit consented to come under New Regulations and sought for one basic unit in M.Ed., which requires additional facilities.

4. **AND WHEREAS**, it has been decided to permit the institution to have one basic unit of 50 students subject to the institution fulfilling following conditions namely.

- (i) The institution shall create additional facilities that include (a) additional built-up-area, (b) additional infrastructure, (c) additional funds, (d) adhere to staff norms as per Regulations, 2014 and inform Regional Committees with required documents by October 31, 2015.
- (ii) The application-Institution for additional unit will be required to submit the required documents such as land documents, Encumbrance Certificate (EC), Land Use Certificate (LUC) and the Building Plan (BP) in the specified proforma available on the website to the Regional Committee in proof of having provided additional facilities before October 31, 2015. Building completion Certificate (BCC) may be given along with other documents if available, otherwise it can also be given to the Visiting Team at the time of inspection.
- (iii) The Regional Committees shall arrange for verification of documents, inspection of these premises and check adherence to these condition by 20 February, 2016. If it is found by the Regional Committee that the institution fails to comply with these requirements, the institutions shall not be permitted to admit students for the academic year 2016-2017.
- (iv) In case any existing institution's matter is sub-judice under court direction/SCN under section 17 of the NCTE Act/ Complaint etc., the institution shall be required to submit a copy of the Hon'ble Court order/reply to SCN/complaint/already submitted alongwith the documents, if any together the documents referred above. In case the institution's request for shifting of premises is pending, such institution shall be required to submit the requisite documents as per provisions of the NCTE Regulations, 2014 with a copy of the order/NOC of the affiliating body/State Govt. and such other documents as indicated in the revised format recognition order. The final decision shall be subject to the directions given by the Hon'ble Court in the Writ-Petition/case decided by the Northern Regional Committee in respect of Section 17/complaint cases etc.

5. **Now therefore**, in the light of the above, the Northern Regional Committee, NCTE hereby issues the revised Recognition Order to **Saraswati College of Education, Khewat No. 723 Min/690, Khatoni No. 779 Min, Rect No. 29, Killa No. 20, 21, 22, Rect No. 46, Killa No. 1/2, 2, Kawi Road, Madlauda, Panipat, Haryana** for conducting M.Ed. programme of two years duration with an annual intake of 50 for one basic unit of 50 students from the academic session 2015-2016 subject to fulfillment of the conditions mentioned herein before 31.10.2015.

6. Further, the recognition is subject to fulfillment of other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.
7. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
8. The institution shall maintain & update its website as per provisions of NCTE Regulations and always display following as mandatory disclosure.

- (a) Sanctioned programmes along with annual intake in the institution.
- (b) Name of the faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
- (c) Name of faculty members who left or joined during the last quarter.
- (d) Names of students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.
- (e) Fee charged from students.
- (f) Available infrastructural facilities.
- (g) Facilities added during the last quarter.
- (h) Number of books in the library, journals subscribed to and additions, if any, in the last quarter.
- (i) The affidavit with enclosure submitted along with application.
- (j) The institution shall be free to post additional relevant information, if it so desires.
- (k) Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

If the institution Contravenes any the above conditions or the provision of the NCTE Act, Rules, Regulations and Orders made and issued there under, the institution will render itself liable to adverse action including withdrawal of recognition by the Regional Committee under the provisions of Section 17(1) of the NCTE Act.

WHEREAS in terms of Section **15(1)** of the NCTE Act, 1993 **Saraswati College of Education, VPO- Madlauda, Kauli Road, Tehsil- Madlauda, Distt- Panipat, Haryana, (HR- 1108)** has submitted an application (**Code No. APN05088**) to the Northern Regional Committee of NCTE for grant of recognition/permission for starting **M.Ed. Course of one year** duration with an annual intake of **25 (Twenty five only)** students on **17.11.2007**.

2. AND WHEREAS the competent authority had constituted a Visiting Team to visit the institution on **06.05.2008**

3. AND WHEREAS the matter was placed in **154<sup>th</sup> Meeting held on 09<sup>th</sup> to 11<sup>th</sup> January 2010**. The Northern Regional Committee after considering the application and reply submitted by the institution, the documents attached therewith, the affidavit and the input received from the visiting team in the form of report and videography, recommendation of the State Government, was satisfied that the applicant institution does not full fill the requirements and has decided to refuse recognition of the institution. Accordingly, Refusal order was issued vide order No. **F.NRC/NCTE/F-7/HR-1108/2009/15443 dated 21.01.2010**.

4. AND WHEREAS the institution has preferred an appeal on **12.02.2010** against the refusal order of NRC dated **21.01.2010** to the Appellate Authority. The appeal of the institution was accepted and NRC's order dated **21.01.2010** was set aside by the appellate authority with direction to the NRC to grant formal recognition to the institution under clause 7(11) of NCTE Regulations vide order dated **12.04.2010**.

5. NOW, THEREFORE, in exercise of the powers vested under Section 15(1) (a) of the NCTE Act, 1993, the Northern Regional Committee hereby grants permission to **Saraswati College of Education, VPO- Madlauda, Kauli Road, Tehsil- Madlauda, Distt- Panipat, Haryana** or conducting **M.Ed. Course of one year** duration with an annual intake of **25 (Twenty five only)** Students from the academic session **2009-2010** under clause 7(11) of NCTE Regulation, 2007 notified on 10-12-2007 subject to fulfillment of the following:

6. The admission of students shall be made only after affiliation by the examining body before the commencement of the academic session and the admission of students shall be completed well before the cut off date prescribed by the examining body for the academic session 2009-2010 failing which the recognition will be effective from the academic session 2010-2011 only.

5. Formal orders for recognition/permission will operate for 2009-2010 only if the requirement of 180 teaching days in the session is fulfilled as per calendar of the University/Affiliation Body.

6. The institution shall, within one month of the receipt of recognition order, convert the endowment fund and reserve fund accounts into joint accounts to be operated along with an officer of the Northern Regional Committee.

7. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed under relevant norms and standards of NCTE for other regulatory bodies like UGC, the State Government etc, wherever applicable.

8. The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.

9. The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE Regulations, 2007 notified on 10-12-2007.

10. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant together with statement of T.D.S. in respect of the salary paid to the staff. A copy of the format is enclosed with the order.

11. If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as stipulated provisions of Section 17(1) of the NCTE Act.

12. The institution shall maintain & update its Web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure: -

- Copy of the Application Form
- Land and Building Particulars
- Staff Profile
- Recognition letter
- Information for having fulfilled the norms & standard and other required conditions.

13. In case if the land is in the name of the Society, you must transfer the land within six month in the name of the institution failing to which action shall be initiated to withdraw the recognition. It shall be essential on the part of the institution concerned to get the needful done in this regard and intimate the respective Regional Committee along with the new land document within the stipulated time.
