WHEREAS the institution namely Haryana College of Education, Ellenabad, Near AmbedkarChowk By Pass Raod, Village-DhaniBachan Singh, Post office-Ellenabad, Distt.-Siras, State-Harvana, was granted recognition vide NRC order No. NRC/NCTE/HR-1413/2008/60368-74 dated 03.09,2008 for B.Ed. course of two year duration with an annual intake of 100 (Hundred only) students.

AND WHEREAS, the matter was considered by the NRC in its 268th meeting held from 19th to 21st April. 2017 and the Committee decided as under:-

- The institution has yet not submitted the certified registered land documents issued by the Registering Authority or civil authority concerned.
- The institution has not submitted the Non-Encumbrance certificate issued by the Competent Authority indicating that the land is free from all encumbrances.
- The institution has not submitted the readable approved Building plan signed by the Competent Govt, Authority indicating the name of the course, name of the institution, Khusra No./Plot No., total land area, total built-up area and the measurements of the Multi-purpose Hall as well as the other infrastructural facilities such as class rooms etc.

Hence, the Committee decided that the recognition of the institution is withdrawn u/s 17 of the NCTE Act, 1993. FDRs, if any, be returned to the institution.

AND WHEREAS, the withdrawal order was issued to the institution on 25.04.2017.

AND WHEREAS, the institution filed an appeal in the NCTE Hq. against the NRC order dated 25.04.2017 and the appeal committee considered the matter and passed an order dated 21.08.2017 as under:

AND WHEREAS after perusal of the memorandum of appeal, affidavit documents on record and oral arguments advanced during the hearing, Appeal Committee concluded to set aside the impugned refusal order dated 25.04.2017 and recognition granted earlier stand restored.

AND WHEREAS, the matter was considered by the NRC in its 274th meeting held from 29th to 31st August, 2017 and the committee decided as under:-

In compliance with the Order dated 21.8.2017 of the Appeal Committee, NCTE (HQ), New Delhi, the Committee decided that recognition granted to the institution vide Order dated 03.09.2008 for B.Ed. course for two units is restored.

NOW, THEREFORE, the recognition of the institution is hereby restored which was granted vide Order dated 03.09.2008 for B.Ed. course of two years duration with an annual intake of 100 students (two units) to "Haryana College of Education, Ellenabad, Near AmbedkarChowk By Pass Raod, Village-DhaniBachan Singh, Post office-Ellenabad, Distt.-Siras, State-Haryana."

The institutions shall adhere to the fulfillment of the provisions of the NCTE Regulations, 2014 and ensure the following before commencement of the session: -

- (i) The institution shall comply with various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
- (ii) The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- (iii) The institution shall comply with the condition as laid down in the clause 8(3) of the NCTE Regulations, 2014 which provided that "An institution which has been recognized by the Council shall obtain accreditation from an accrediting agency approved by Council within five years of such recognition."
- The institution shall ensure that the required number of academic staff for conducting the course is always in position.

Further, the recognition is subject to fulfilment of all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/ Body, the State Government etc. as applicable and compliance of the following by the affiliating body, State Govt and also the concerned recognised Institution: -

- (i) The affiliating bodies/State Govt. shall be required to verify the authenticity of the land & building documents with the required land & built up area as well as appointment of requisite teaching & non-teaching staff as per provisions of the NCTE Regulations, 2014 by the concerned institution before grant of affiliation to an institution.
- (ii) The affiliating body shall ensure that the institution is composite institution as per the definition of composite institution given in the NCTE Regulation, 2014. If at any stage, it is found that the institution as not a composite institution, the recognition, granted will be treated as withdrawn and the sole responsibility of the same will be of the institution. However, in the existing institutions permitted for additional intake, shall have to ensure that they are to become composite gradually preferably the academic session 2016-17.
- (iii) The staff approval thereof submitted by the institution, if found take at any stage, the recognition, granted will be treated as withdrawn and the sole responsibility of the same will be of the institution.

The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant.

The institution shall maintain & update its Web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure: -

- Copy of the Application Form (i)
- Land and Building Particulars (ii)
- Staff Profile (iii)
- (iv) Recognition letter
- Information for having fulfilled the norms & standard and other required conditions. (v)

In case if the land is in the name of the Society/trust, the land is to be transferred within six months in the name of the institution, failing which action shall be initiated to withdraw the recognition. It shall be essential on the part of the institution concerned to get the needful done in this regard and intimate about the same ... the respective Regional Committee along with the new land documents within the stipulated time.

If the institution contravenes any of the above conditions or the provisions of the NCTE Act. Ludes, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as under the provisions of Section 17(1) of the NCTE Act.

The Educational Institution shall follow Uniform Accounting System as brought out by ICA1 and accepted by MHRD.

The Institution shall fill the GIS Application within one month of issue of this order.

Further, if the institution is not satisfied with the order, it may prefer an appeal under sections 48 of ACTE Act, 1993 in the "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of this order.
