NOW, THEREFORE, the recognition of the institution is hereby restored which was granted vide Order dated 20.09.2007 and 23.06.2015 for B.Ed. course of two years duration with an annual intake of 100 students (two units) to "Apex College of Education, Plot No.-54-55, Village-Bidhaikhera, Tehsil-Tohana, Distt.-Fatehabad, State-Haryana."

The institutions shall adhere to the fulfillment of the provisions of the NCTE Regulations, 2014 and ensure the following before commencement of the session: -

(v) The Norms of staff/ qualifications/administrative and professional staff/terms and conditions of service etc. shall be as per the provisions of NCTE Regulations, 2014.

Further, the recognition is subject to fulfilment of all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/ Body, the State Government etc. as applicable and compliance of the following by the affiliating body, State Govt and also the concerned recognised Institution:

(i) The affiliating bodies/State Govt. shall be required to verify the authenticity of the land & building documents with the required land & built up area as well as appointment of requisite teaching & non-teaching staff as per provisions of the NCTE Regulations, 2014 by the concerned institution before grant of affiliation to an institution.

(ii) The affiliating body shall ensure that the institution is composite institution as per the definition of composite institution given in the NCTE Regulation, 2014. If at any stage, it is found that the institution as not a composite institution, the recognition, granted will be treated as withdrawn and the sole responsibility of the same will be of the institution. However, the existing standalone institutions shall gradually move towards becoming composite institutions.

WHEREAS the institution namely Apex College of Education, Plot no. 54-55, Village-Bidhaikhera, Tehsil-Tohana, Distt.-Fatehabad, State-Haryana was granted recognition vide NRC order No. F. No./F.NRC/NCTE/F-73/HR-711/28259-95 dated 20.09.2007 for B.Ed. course with annual intake 100 students followed by revised recognition order No. NRC/NCTE/HR- Common Orders/2015/117528-34 dated 23rd June, 2015 with annual intake of 2 units (100 students).

- No explanation has been submitted by the institution regarding having less land and built up area except an affidavit dated 27.03.2017.
- No explanation has been submitted by the institution with regard to increase in the infrastructure
- No proof of appointment for Principal on regular basis has been submitted, after observation of the Visiting Team.
- The institution has not yet submitted the certified registered land documents issued by the Registering Authority or civil authority concerned.

Hence, the Committee decided that the recognition granted to institution for running B.Ed. course is withdrawn u/s 17 of the NCTE Act, 1993 from the end of the academic session next following the date of order of withdrawal. FDRs, if any, be returned to the institution.

Accordingly, Withdrawal Order was issued to the institution on 12th April, 2017.

AND WHEREAS, the institution filed an appeal before NCTE Hq. against the NRC Order dated 12.04.2017 and the Appeal Committee considered the matter and passed an order dated 21.08.2017 thereby remanding back the matter to NRC.
