RESTORATION ORDER

0 4 SEP 2019

WHEREAS, recognition was granted by the Northern Regional Committee to Basant Lal Memorial College of Education, VPO- Garhi Harsaru, Tehsil & District- Gurgaon, Haryana-123505 vide Order No. F.NRC/NCTE/HR-1153/2008/56299 dated 13.08.2008 for D.Ed. course of two years duration with an annual intake of one unit of 50 students.

- 2. AND WHEREAS, the matter was placed before NRC in its 160th meeting held from 18th to 20th May, 2010 and the Committee decided as under:-
 - Language lab is ill equipped.
 - HoD for D.Ed. is not selected through duly constituted selection committee.
 - Multipurpose Hall is small in size.

Hence, the committee decided to withdraw the D.Ed. recognition from 2010-2011 academic session.

- 3. AND WHEREAS, Withdrawal Order was issued on 10th June, 2010 to the institution.
- 4. AND WHEREAS, the institution filed an appeal against the above order and the Appeal Committee passed an order dated 27.08.2010 hereby confirm the Order of NRC-NCTE.
- 5. AND WHEREAS, the institution filed W.P. (C) No. 11699/2018 & CM APPL. 45258/2018 in the Hon'ble High Court of Delhi at New Delhi. The Hon'ble Court passed an order on 01.08.2019. The operative part of court order is as under: -

".....This court, therefore, declares that the petitioner institution is entitled to undertake the D. Ed. course, and stands duly recognised and authorised to do so, by the NRC, and by the SCERT. It is also declared that the order dated 10th June, 2010 (supra), of the NRC, whereby the petitioner's recognition has been withdrawn and the appellate order dated 27th August, 2010 (supra) do not survive, in fact or in law, after the judgment dated 8th September, 2010 (supra) in W.P. (C) 5995/2010. Further the impugned communication dated 16th October, 2018 (supra), of the NRC, to the SCERT and the impugned communication dated 23rd October, 2018 (supra), from the SCERT to the petitioner, are quashed and set aside.

In case the exercise of counseling, for the conducting of the D. Ed. course in the 2019-2020 academic session has not been completed, the petitioner institution shall be permitted to participate therein. In case the said exercise is completed, a fresh exercise of counseling shall be conducted, for the D. Ed. course being conducted by the petitioner.

The writ petition is allowed in the above terms.

In the facts and circumstances of this case, Respondent No. 1 is burdened with costs, which are quantified at ₹ 50,000/-, to be paid to the petitioner within a period of two weeks from the date of receipt of a certified copy of this judgment."

- 6. AND WHEREAS, the matter was placed before NRC in its 306th meeting held from 28th to 30th August, 2019 and the committee decided as under:-
 - 1. Restore the recognition order from the academic session 2010 to 2019-20.
 - 2. Application should be filed for waving off the cost imposed by the hon'ble High Court of Delhi.
 - 3. Recognition shall be continued for the session 2020-21 subject to the condition that the institution shall be inspected to verify the infrastructure or institutional facilities as per NCTE Regulations, 2014.
 - 4. The name of the institution entitled "Basant Lal Memorial College of Education" shall be uploaded in the NRC- NCTE website/portal.
- 7. NOW, THEREFORE, the NRC restore the recognition of the institution granted vide Order No. F.NRC/NCTE/HR-1153/2008/56299 dated 13.08.2008 for **D.Ed.** course of two years duration with an annual intake of one unit of 50 students.
- 8. The institution shall adhere to the fulfillment of the provisions of the NCTE Regulations, 2014, as amended from time to time, and ensure the following before commencement of the session: -
 - (i) The institution shall comply with various other norms and standards prescribed in the NCTE Regulations, as amended from time to time.
 - (ii) The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
 - (iii) The institution shall comply with condition laid down in clause 8(3) of the NCTE Regulations, 2014, as amended vide notification on 29.04.2017 which provides as under:-
 - An institution, which has been recognised by the Council shall obtain accreditation from an accrediting agency indentified by the Council within five years of the date of recognition.
 - All existing Teacher Education Institutions which have not been accredited so far or have not been accredited within five years from the date of its recognition shall be required to get themselves accredited by the aforesaid accrediting agency within a period of one year from the date of notification of these Regulations.
 - The accreditation once obtained shall be valid for a period of five years and the recognised and already accredited Teacher Education Institutions shall be required to get accreditation renewed by the agency identified for the purpose by the Council before the lapse of the earlier accreditation.
 - (iv) The institution shall ensure that the required number of academic staff for conducting the course is always in position.
 - (v) The Norms for teaching staff in respect of their qualifications and experience shall be as per provisions of NCTE Regulations, 2014, as amended from time to time.
- 9. Further, the recognition is subject to fulfilment of all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating university/ Body, the State Government etc. as applicable and compliance of the following by the affiliating body, State Govt and also the concerned recognised Institution may be ensured: -
 - (i) The affiliating bodies/State Govt. shall be required to verify the authenticity of the land & building documents with the required land & built up area as well as appointment of requisite

teaching & non-teaching staff as per provisions of NCTE Regulations, 2014 made by the concerned institution before grant of affiliation to the institution.

(ii) The affiliating body shall ensure that the institution is a composite institution as per the definition of composite institution given in the NCTE Regulation, 2014. If at any stage, it is found that the institution is not a composite institution, the recognition, granted shall be treated as withdrawn and the sole responsibility of the same will be of the institution. However, the existing stand-alone institutions shall gradually move towards becoming composite institutions.

(iii) The NOC of the affiliating body and staff approval thereof submitted by the institution, if found fake at any stage, the recognition granted shall be treated as withdrawn, and the sole

responsibility of the same will be of the institution.

10. The institution shall submit a Self-Appraisal Report to the Regional Committee at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.

- 11. The institution shall maintain & update its Web-site as per provisions of NCTE Regulations and always display as mandatory disclosure the following: -
 - (i) Copy of the Application Form
 - (ii) Land and Building Particulars
 - (iii) Staff Profile
 - (iv) Recognition Order
 - (v) Information for having fulfilled the norms & standards and other required conditions.
- In case if the land is in the name of the Society/Trust, the land is to be transferred within six months from the date of recognition order in the name of the institution, failing which action shall be initiated withdrawal of recognition. It shall be essential on the part of the institution concerned to get the needful done in this regard and intimate about the same to the Northern Regional Committee along with the new land documents within the stipulated time.
- 13. If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules and Regulations, the Regional Committee shall withdraw the recognition under the provisions of Section 17(1) of the NCTE Act, 1993.
- 14. The Institution shall follow Uniform Accounting System as brought out by ICAI and accepted by MHRD
- 15. The Institution shall fill the GIS Application on NCTE website within one month from the date of the order.
- 16. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this Order. The guidelines for filing appeal may be seen on NCTE's website.
