ORDER

WHEREAS, in exercise of the powers conferred by sub-section (2) of Section 32 of the National Council for Teacher Education Act, 1993 (73 of 1993) and in supersession of the National Council for Teacher Education (Recognition Norms and Procedure) Regulations, 2009, the National Council for Teacher Education has notified the Regulations, 2014 on 01.12.2014.

- 2. AND WHEREAS, the institution i.e B.P.S. College of Education, VPO Bhaini, Maharajpura, Mehan, Rohtak, Haryana, has been recognized for B.Ed course by NRC vide order No. F.NRC/NCTE/F-3/ HR-1073/212th Meeting/2012/38251-257 dated 01st March 2013 dated 5th April 2013 and F.NRC/NCTE/F-3/ HR-1073/212th Meeting/2012/40097-102 dated 5th April 2013 with an annual intake of 100.
- 3. AND WHEREAS, the institution has by affidavit consented to come under New Regulations and has sought for two basic units in B.Ed., which requires additional facilities.
- 4. AND WHEREAS, it has been decided to permit the institution to have two basic units of 50 students each, subject to the institution fulfilling the following conditions, namely:-
 - (i) The institution shall create additional facilities that include (a) additional built-up-area, (b) additional infrastructure, (c) additional funds, (d) adhere to staff norms as per Regulations, 2014 and inform Northern Regional Committee, with required documents by October 31, 2015.
- (ii) The institution for additional unit will be required to submit the required documents such as, land documents, non-encumbrance Certificate (EC), Land Use Certificate (LUC) and the Building Plan (BP) in the specified proforma available on the website to the Regional Committee in proof of having provided additional facilities before October 31, 2015. Building completion Certificate (BCC) may be given along with other documents, if available, otherwise it can also be given to the Visiting Team at the time of inspection.
 - (iii) The Regional Committee shall arrange for verification of documents, inspection of these premises and check adherence to these conditions by 20 February, 2016. If it is found by the Regional Committee that the institution fails to comply with these requirements, the institution shall not be permitted to admit students for the academic year 2016-2017.
 - In case any existing institution's matter is sub-judice under court direction/SCN under section 17 of the NCTE Act/ Complaint etc., the institution shall be required to submit a copy of the Hon'ble Court order/reply to SCN/complaint/already submitted alongwith documents, if any, together with the documents referred above. In case the institution's request for shifting of premises is pending, such institution shall be required to submit the requisite documents as per provisions of the NCTE Regulations, 2014 with a copy of the order/NOC of the affiliating body/State Govt. and such other documents as indicated in the revised recognition order. The final decision shall be subject to the directions given by the Hon'ble Court in the Writ Petition/case decided by the Northern Regional Committee in respect of Section 17/complaint cases etc.
- 5. Now therefore, in light of the above, the Northern Regional Committee, NCTE hereby issues the revised Recognition Order to B.P.S. College of Education, VPO Bhaini, Maharajpura, Mehan, Rohtak, Haryana for conducting B.Ed. programme of two years duration with an annual intake of 100 students, for two basic units of 50 students, from the academic session 2015-2016 subject to fulfillment of the conditions mentioned herein before 31.10.2015.

WHEREAS, the **B.P.S.** College of Education, VPO- Bhaini, Maharajpura, Meham, Rohtak, Haryana, has applied for grant of recognition / permission for **B.ED.** Course of **one** year duration to Northern Regional Committee on **13.11.2007.**

- 2. AND WHEREAS, the inspection of the institution was conducted on **17.10.2008** under section 14 of the NCTE Act, 1993. Northern Regional Committee in its $\mathbf{134^{th}}$ meeting held from $\mathbf{20^{th}} \mathbf{22^{nd}}$ November, **2008** decided to keep pending all B. Ed. Proposal of various institution including new visiting team reports till further order from the NCTE Hqtrs.
- 3. AND WHEREAS, the matter was placed in **NRC 138th Meeting held from 14th to 16th March, 2009** and Committee decided to issued Show Cause Notice. Accordingly a Show Cause Notice was issued on 25.03.2009.
- 4. AND WHEREAS, the matter was placed in **NRC 141th Meeting held from 22nd to 24th May, 2009** and Committee decided that Deferred for want of information regarding authority competent to issue CLU. This information is being sought from the State Government of Haryana.
- 5. AND WHEREAS, the matter was placed in NRC **146th Meeting held from 5th to 7th August, 2009** and Committee decided to constitute VT. However, the Institution is given 21 days for submission of CLU failing which the matter shall be referred to NRC for closing the file on this ground.
- 6. AND WHEREAS, the inspection of the institution was conducted on **04.09.2009** under section 14 of the NCTE Act, 1993. Northern Regional Committee in its **154**th **Meeting held from 9**th **to 11**th **January, 2010** and Committee decided that the CD of VT visit has been damaged. Thus the VT may be sent again.
- 7. AND WHEREAS, the inspection of the institution was conducted on **13.02.2010** under section 14 of the NCTE Act, 1993. Northern Regional Committee in its **159th Meeting held from 28th April to 1st May, 2010** decided to issue Show Cause Notice. Accordingly a Show Cause Notice was issued on 14.05.2010.
- 8. AND WHEREAS, the matter was placed in **NRC 162nd Meeting held from 24th to 27th June, 2010** and Committee decided to close the file and return FDRs if submitted. Accordingly an order was issued on 22.07.2010.
- 9. AND WHEREAS, The institution preferred an appeal to the Appellate Authority against the NRC order dated 22.07.2010 and Council reversed the NRC's order with direction to NRC to consider the reply dated 17.05.2010 of the institution to the show cause notice and take appropriate decision.
- 10. AND WHEREAS, the reply of the institution dated 17.5.2010 w.r.t. the Show Cause Notice dt. 14.5.2010 etc. has been carefully considered in compliance to the orders of the Appellate Authority by NRC in its 169th Meeting held from 12th to 13th October, 2010 and Committee made the following observations:
 - The contention of the President of the Society that construction of the building is complete
 has been supported by a building completion Certificate on Rs. 10.00 Non-Judicial Stamp

Paper signed by Tehsildar. The paper is not accepted. Building Completion Certificate has not been issued by the office of the Tehsildar. The proof in form of photograph that the building is complete, is acceptable only to the limited extent that front elevation of the building has been completed. No documents or picture supporting the fact that door/window are now installed has been proved.

The revised building plan giving Khasra No. etc. may be accepted.

The observation of the VT that size of library and Multipurpose Hall is small is still valid as the dimensions shown in the map are not actually reflected in the building, which has been physically inspected by the VT. CD clearly indicates that the library has no sitting space, and the institution has provided a separate reading room to cope up with the deficiency. Similarly the multipurpose hall is apparently very small, as it had only 40-50 plastic chairs at the time of inspection and the same number is being shown in the fresh photographs of Multipurpose hall submitted now in response to the Show Cause Notice. Moreover, Multipurpose hall has not been built up with a raised dias and a Public Address System.

The institution did not make any efforts to develop ET and ICT Labs, the labs are still not up to the mark. The computer tables have been provided but instead of matching, separate chairs for each table, combined long benches have been kept for 2-3 computers, making it totally non-functional. This is even clear in the new photograph submitted by the

institution.

As such, it is clear that institution did not take enough care to make up the deficiencies pointed out in the final Show Cause Notice. The institution is therefore unfit to organize a B.Ed. course hence, the NRC decided to refuse the application of the institution under section 14(3)(b) of NCTE Act 1993.

NOW THEREFORE, recognition to B.P.S. College of Education, VPO- Bhaini, 11. Maharajpura, Meham, Rohtak, Haryana, for the course in B.ED. Course is hereby refused.

If the institution is not satisfied by the above order they can prefer and appeal to the council in terms of section 18 of NCTE Act, 1993.
