#### ORDER

WHEREAS, vide covering letter dated January 21, 2004, the institution, namely, Amity Institute of Education, having address at "Amity Campus, Yasho Bhawan, opposite Holy Family Hospital, Okhla, New Delhi" has made application to Northern Regional Committee (in short NRC), Jaipur seeking permission to start new course of Elementary Teacher Education with an annual intake of 200 students from academic session 2004-2005. However, the NRC in its 90th meeting held on 22nd and 23rd April, 2005 decided to refuse the application/permission for the reasons mentioned in the order dated 08th June, 2005 communicated by the office to the institution in pursuance to the said decision.

- 2. AND WHEREAS, the aforesaid order having been reversed by the Appellate Authority, NCTE-New Delhi vide its order dated 28<sup>th</sup> September, 2005 in an appeal preferred by the institution under section 18 of the NCTE Act, 1993, the NRC in its 97<sup>th</sup> meeting held on 27<sup>th</sup> and 28<sup>th</sup> October, 2005 has decided to implement the aforesaid decision of the NCTE.
- 3. NOW THEREFORE, in exercise of the powers vested under Section 15 (3) (a) of the NCTE Act, 1993, the Northern Regional Committee hereby grants permission to Amity Institute of Education, Amity Campus, Road No. 44, M-Block, Saket, New Delhi for ETE course of two years duration w.e.f. 28<sup>th</sup> October, 2005 with an annual intake of 50 (Fifty) students in the 1<sup>st</sup> year and the same for the 2<sup>no</sup> year subject to fulfillment of the following:-
  - (a) Appointment of the faculty members duly qualified and staff as per the norms of NCTE/State Govt./UGC/SCERT is to be completed before commencement of the session.

(b) The countersigned statement of all faculty members from the Director, SCERT should be submitted before the commencement of the academic session.

(c) The institution shall adhere to all other regulations and guidelines as framed by NCTE from time to time.

(d) The institution shall within one month of the receipt of this order, convert the Endowment Fund account into a joint Account in the form of FDR for a period of not less than 60 months (Five Years) In a

That the Reserve fund for an amount of equal to three months salary of the Teachers & Staff be (e) created within one month from the date of issue of this order and maintained in the form of FDR in favour of the management/institution, for a period of 60 months (Five Years) in than less Nationalized Bank.

Before starting the course the institution should seek prior permission of the competent authority for conducting the exams and approval of the curriculum " (f)

that they are going to adopt for the course.

Institutions if starts the training programme without prior approval / permission of the competent authority / examining body regarding the curriculum (g) that they have adopted and conduct of examinations for award of Diploma / Certificate the recognition of such institutions shall stand withdrawn.

Non-compliance of the above mentioned conditions shall cause action under section 17 (1) of NCTE Act,

1993.

- 4. The Recognition is subject to the condition that the affiliating body shall ensure that, among other things, the institution has appointed required number of faculty members (including Principal / Head of Department), as per the norms of the NCTE/UGC/Affiliating Body.
- Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC and State Government, etc.
- The institution shall submit to the Regional Committee a Self Appraisal Report at the end of each academic year along with a copy of the approval of the affiliating University / State Directorate of Education about the appointment of faculty members and the Statement of Annual Accounts duly audited by a Chartered Accountant.
- If the institution contravenes any of conditions or any of the provisions of the NCTE Act, Rules, Regulations and orders made or issued thereunder, the Regional Committee may withdraw the recognition under the provisions of Section 17 (1) of the NCTE Act.




