## SHOW CAUSE NOTICE U/S 17

WHEREAS, recognition was granted to the institution namely Nagarjuná College of Education, Nagarjuna Nagar, Miryalguda Nalagonda District-508207, Andhra Pradesh run by Nagarjuna Educational Society, Nagarjuna Nagar, Miryaguda Nalagonda District-508207, Andhra Pradesh vide SRC (NCTE) order no. F.AP/NEW/SEC/70/SRO/NCTE/2002-2003/6137 dt. 03.03.2003 for conducting B.Ed. course of one-year duration with an annual intake of 100 students from the academic session 2002-2003.

AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution is submitted affidavit dt 23.01.2015 for its willingness for adherence of provisions of new Regulations.

AND WHEREAS, a Revised Provisional Recognition Order was issued to the institution on 12.05.2015 for conducting B.Ed. course of two years duration with an annual intake of100 (Two basic units) from the academic session 2015-16.

AND WHEREAS, on the basis of request, the SRC in its 342<sup>nd</sup> meeting decided for reduction of intake from 2 units to 1 unit. Accordingly an order dated 21.7.2017 was issued.

AND WHEREAS, the SRC in its 369th meeting held on 28.01.2019 and the Committee decided that Show Cause Notice be issued to all such institutions which have not submitted compliance. Accordingly, as per the decision of SRC a show cause notice was issued to the institution on 19.02.2019. The institution vide letter dated 16.03.2019 submitted reply to the show cause notice.

AND WHEREAS, the SRC in its 376th meeting held on 11th - 12th June, 2019 considered the matter and decided as under:

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

The Committee decided to issue Show Cause Notice u/s 17 of NCTE Act, 1993 for B.Ed course before withdrawal of the recognition on the following grounds :-

- 1. The institution is required to submit certified copy of land documents. (If the same are in Regional Language the institution is also required to submit notarized copy of English version of land documents)
- 2. Land Use Certificate issued by the Competent Authority.
