WITHDRAWAL ORDER UNDER SECTION 17 OF NCTE ACT, 1993

Whereas, the institution namely Christ College of Education for Women, No.102, A/4, 10 (Parry Matriculation School Road), Mela Mettu Street, Vallam, Thanjavur District-613403, Tamilnadu was granted recognition vide SRC (NCTE) order no. F.SRO/NCTE/B.Ed./2006-2007/16998 dt. 11.01.2008 for conducting B.Ed. course of one year duration with an annual intake of 100 students.

And whereas, the institution submitted a letter dt. 15.05.2012 informing the SRC that the institute has been shifted to their permanent campus at No.1626, Christ Academy Campus, First Street, Rahuman Nagar, Medical College Road, Thanhavur-613004, Tamilnadu.

And whereas, it is submitted that no formal order was issued by the SRC permitting the institution to shift from location 1021, A/4, 10 (Parry Matriculation School Road), Mela Methu Street, Vallam, Thanjavur, Tamilnadu-613403 to No.1626, Christ Academy Campus, First Street, Rahuman Nagar, Medical College Road, Thanhavur-613004, Tamilnadu.

And whereas, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dt. 30.04.2015, for its willingness of two units in B.Ed. course and adherence of provisions of new Regulations.

And whereas, provisional revised recognition order was issued to the institution on 25.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 (two basic units) from the academic session 2015-16.

And whereas, the institution vide letter dt.03.11.2015 submitted compliance of conditions of RPRO issued in respect of B.Ed. course.

And whereas, the matter was considered by the SRC in its 316th meeting held on 7th & 8th July, 2016 wherein the following was decided: -

- 1. Title deed is given. Long-term leased hold title is clear.
- 2. EC is clear.
- 3. LUC is not approved by competent authority.
- 4. BP, BCC both are not legible and, therefore, not clear. BCC is not in format.
- 5. Original FDRs-not given.
- 6. Faculty list-not given.
- 7. Processing Fee-not paid.
- 8. Collect Fee for the 2nd unit of B.Ed. and Cause Inspection for shifting of B.Ed (2 units).
- 9. Ask VI to collect all relevant documents: and, check on adequacy of build-up area.

And whereas, the decision was communicated to the institution vide letter dt. 03.08.2016.

And whereas, the institution submitted a representation vide letter dt. 08.08.2016.

And whereas, the matter was considered by the SRC in its 351st meeting held on 28th & 29th December, 2017 wherein the following was decided:-

- 1. This is a RPRO 'Shifting' case.
- 2. If information about adequacy of built-up area is available, we need not inspect for issue of new FR.
- 3.1. But, in this case, inspection is required for shifting.
- 3.2. Shifting Inspection has to be by NCTE. Affiliating Body's inspection cannot replace that.
- 4. Collect fee and cause inspection for B.Ed. (2 units).
- 5. Ask VT to collect all relevant documents LUC, BP, BCC, FDRs (in original in joint account) and latest approved Faculty list.
- 6. Issue SCN accordingly.

And whereas, as per the decision of the Committee the Show Cause Notice was issued on 16.01.2018.

And whereas, it is pertinent to mention that the institution has not submitted any compliance till date.

And whereas, the matter was considered by the SRC in its 376th meeting held on 11th – 12th June, 2019. The decision of SRC is reproduced below:

The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

"The SRC observed that the institution has not submitted any reply to Show Cause Notice dt. 16.01.2018 and hence decided to withdraw the recognition of B.Ed. course granted vide order dt. 11.01.2008 w.e.f. the academic session 2019-20 under clause 17(1) of NCTE Act, 1993."

Now therefore, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition of Christ College of Education for Women, No.102, A/4, 10(Parry Matriculation School Road), Mela Mettu Street, Vallam, Thanjavur District-613403, Tamilnadu was granted recognition vide SRC, NCTE's vide order no. F.SRO/NCTE/B.Ed./2006-2007/16998 dt. 11.01.2008 for conducting B.Ed. course of one year' duration with an annual intake of 100 students from the next academic session starts after issuance of this order.

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act:-

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purposes of employment under the Central Government, any State Government or University, or in any school, college or other educational body aided by the Central Government or any State Government."

Further, if the institution is not satisfied with the Order, it may prefer an Appeal u/s 18 of the NCTE Act, 1993, through "online mode" available on NCTE's website www.ncte-india.org. within 60 days from the date of issue of this Order. The guidelines for filling appeal may be seen on NCTE's website.
