ORDER

WHEREAS, HMS Education Society, Settyhally Road, Tumkur District-572102, Karnataka submitted an application on 30.12.2003 in the name of Rajiv Gandhi College of Education seeking grant of recognition for starting B.Ed course. The application was processed and recognition for offering B.Ed course with an intake of 100 students was granted on 25.11.2004 with a condition to shift to its own premises within three years from the date of recognition (in case the institution is started in rented premises)

2. AND WHEREAS, this office was in receipt of letter No.TY: VCPS: 2011-12:98 dated 21.05.2011 from the Vice-chancellor, Tumkur University, Tumkur enclosing a list of 19 institutions with their committee's observations after conducting inspections. The SRC in its 206th meeting held on 9th-10th June, 2011 noted the inspection report of the Vice-chancellor, Tumkur University, dated 21.05.2011 and the deficiencies in the 19 institutions in Tumkur District and decided to issue show cause notice under section 17 of NCTE Act. Accordingly, a show cause notice was issued to the institution on 08.07.2011. The institution submitted its reply on 01.08.2011.

3. AND WHEREAS, the SRC in its 211th meeting held on 21-23 September 2011 considered the letter dated 21.05.2011 from Vice-Chancellor, Tumkur University pointing out deficiencies in the 19 Tumkur University colleges, and also the reply of the institutions dated 01.08.2011 and other documents submitted by the institution and decided to cause composite inspection for all the courses at premises Under Section 17 of NCTE Act, to verify whether the institution is maintaining instructional and infrastructural facilities as per NCTE norms. The same was informed to the institution vide letter dated 04.10.2011. The inspection of the institution was carried out on 29.10.2011. Tumkur University vide letter received on 17.10.2011 conducted re-visit to the institutions during 15-19 and 27th July, 2011 and made certain observations.

4. AND WHEREAS, the SRC in its 216th meeting held on 11th and 12th January, 2012 considered the VT Report, VCD and all the relevant documentary evidences and decided to serve Show cause Notice under Section 17 of NCTE Act. Accordingly, a Show Cause Notice was issued to the institution on 5.3.2012. The institution submitted reply received on 02.05.2012.

5. **AND WHEREAS**, the SRC in its 226th meeting held on 9th and 10th July, 2012 considered the written reply of the institution and decided to withdraw recognition.

Accordingly, withdrawal order was issued to the institution vide No. APSO 1712-B.Ed./KA/2012-2013/44404 dated 27.07.2012.

6. **AND WHEREAS**, aggrieved by the withdrawal order, the institution preferred an appeal before the appellate authority and the appellate authority vide its Order No.89-577/2012 Appeal/10th Meeting-2012 dated 11.12.2012 confirmed the order of SRC. The institution approached the Hon'ble High Court of Karnataka vide W.P.No.50102/2012 and WP Nos.5737-5786/2013 against R1-NCTE, Bangalore and R2-Tumkur University.

7. **AND WHEREAS**, on 27.3.2013, this office received a copy of the judgment dated 30.1.2013 from the institution.

8. **AND WHEREAS**, the SRC in its 242nd meeting held on 14-16 April, 2013 considered the court order and advised SRO to file an appeal against the Hon'ble Court order dated 27.03.2013.

9. **AND WHEREAS**, the SRC in its 259th Meeting held on 17th – 19th January, 2014 considered the matter, letter dated 25/09/2013 written to the Lawyer requesting to file an appeal in the said case. The Committee advised Regional Director SRO to follow-up with the new lawyer to ensure that appeal is filed and 'stay' is obtained. If necessary, explain details of the case on phone (or, in person) to the Lawyer.

10. **AND WHEREAS**, as per decision of SRC, a letter was sent to advocate on 07.11.2014.

11. **AND WHEREAS**, the institution submitted its written representation on 09.02.2015 along with affidavit for processing of application as per Regulations, 2014 and court order in W.P.No.50102/2012 and W.P.No.5737-5786/2013 (EDN-RES) dated 30.01.2013, two DD's of Rs.40, 000/- and Rs.10, 000/- and relevant documents.

12. **AND WHEREAS**, the SRC in its 280th meeting held on 12-14 February, 2015 considered the matter and decided to Cause Inspection. Inspection of the institution was fixed between 19th to 22nd February 2015, the same was intimated to the institution on 18.02.2015. The inspection of the institution was conducted on 21.02.2015 and the VT report received in the office of SRC on 23.02.2015.

13. **AND WHEREAS**, The SRC in its 282nd meeting held on 26th February, 2015 considered the VT report, and all other documents and decided to Issue show cause notice for the four deficiencies identified in the agenda note.

- In the affidavit Built-up area is not mentioned.
- In the Building Plan Extent is not mentioned.
- Khatha No. is not matching with Encumbrance certificate.
- In the Building Plan SY.No.is written by using pen.

14. **AND WHEREAS**, show cause notice was issued to the institution on 04.03.2015. The institution submitted reply on 02.03.2015.

15. **AND WHEREAS**, the Southern Regional Committee in its 284th Meeting held during 9th to 10th April, 2015 considered the matter, and decided as under;

"1. *Restore recognition.*

2. *Ask them to ensure full compliance with the new norms & standards before 30.10.2015."*

16. **AND WHEREAS**, recognition of the institution was restored vide Order dated 27.04.2015. Revised order was issued to the institution on 31.05.2016 for offering B.Ed course of two years duration with an intake of 2 units of 50 students each.

17. **AND WHEREAS**, the institution submitted letters along with documents on 30.10.2015, 10.05.2016 and 02.06.2016.

18. **AND WHEREAS**, after long deliberations, the matter was finally placed in the SRC 376th meeting held on 11th -12th June, 2019. The SRC committee considered the matter and decided as under: -

The Committee decided that Order for Continuance of recognition for B.Ed. course with an annual intake of 100 (two basic units) (50 students each unit) be issued to the institution.

19. **NOW THEREFORE**, this order is issued permitting the institution **Rajiv Gandhi College of Education, 1st Floor, H.M.S. Campus, Shettyhalli Main Road, Tumkur - 572103, Karnataka** run by **HMS Education Society, Settyhally Road, Tumkur District-572102, Karnataka** for continuation of conducting B.Ed course of two years duration with an intake of 100 students (two basic units of 50 students each) subject of fulfillment of the following conditions

- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.

6. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc as applicable.

7. The institution shall submit to the Regional Committee as Self – Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
8. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter – alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:-
- a. Sanctioned programme(s) along with annual intake in the institution:
 - b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
 - c. Name of faculty members who left of joined during the last, quarter:
 - d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
 - e. Fee charged from students;
 - f. Available infrastructural facilities;
 - g. Facilities added during the last quarter;
 - h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
 - i. The affidavit with enclosure submitted along with application.
 - j. The institution shall be free to post additional relevant information, if it so desires.
 - k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
 - l.
9. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
10. The institution shall make available the list of students admitted on its official website.
11. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued thereunder, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.

Also order that a copy of this Order be published in the official Gazette.
