Show Cause Notice

WHEREAS, Vinootan Shikshana Seva Samsthe®, Alwandi, Koppal District had submitted an application for B.Ed course of one year for grant recognition to Vinootan Shikshana Seva Samsthe Rural College of Education, Koppal, Koppal District-583231, Karnataka. The institution was granted recognition on 09.12.2004 for offering B.Ed course with an annual intake of 100 students with a condition to shift to its own premises within three years from the date of recognition (in case the course is started in temporary premises).

AND WHEREAS, a letter was received from the Registrar, Vijayanagara Sri Krishnadevaraya University on 24.04.2014 regarding status of Rajeev Gandhi B.Ed., college as per records. The detail of the letter is as under:

"Rajeev Gandhi Rural Education & Multipurpose Trust, Dadegal, Koppal is running a B.Ed., College at Dadegal, Koppal District, Karnataka from 2006-07. On perusal of the reocrds submitted by the college, NCTE has granted recognition to Vinootan Shikshana Seva Samsthe Rural College of Education, Koppal-583231 for B.Ed., academic session course(APS02244) from the 2004-05 vide letter No.FSRO/NCTE/B.Ed/2004-05/9215 dated 09.12.2004(encl 1). The same recognition letter and NCTE code is being use by Rajeev Gandhi College of Education B.Ed., Dadegal, Koppal (APS02244)(encl2-Letter head of the college). The trust has not submitted any letter from NCTE regarding the transfer of the college. They have submitted a letter obtained from Government of Karnataka(encl 3) The name of Rajeev Gandhi Rural College of Education B.Ed., Dadegal, Koppal, Karnataka is not found in the list of B.Ed., Colleges hosted on the NCTE Website, but the name of Vinootan Shikshana Seva Samsthe Rural College of Education, Koppal -583231(APS02244) is found on the website. The matter has been reported by the LIC team sent by University to inspect the college (encl 4)

Kindly inform the university about the status of the of Rajeev Gandhi College of Education B.Ed., Dadegal, Koppal as per NCTE records, so as to enable the university to take further action on the college".

AND WHEREAS, The SRC in its 268th Meeting held on 4 – 5 June, 2014 considered the matter, letter dated 24.04.2014 & 15.05.2014 from the Registrar, Vijayanagar Sri. Krishnadevaraya University, and all the relevant documentary evidences and decided to serve Show Cause Notice under NCTE Act for the following:

- NCTE has granted recognition to VinootanShikshanaSevaSamsthe Rural College of Education, Koppal-583231 for B.Ed course (APS02244) from the academic session 2004-05 vide letter No. FSRO/NCTE/B.Ed/2004-05/9215, dated 09.12.2004. Now the same recognition letter and NCTE Code is being used by Rajeev Gandhi College of Education B.Ed, Dadegal,Koppal (APS02244). The Trust has not submitted any letter to NCTE regarding the transfer of the college.
- Later with effect from 2006-07 academic sessions the institute (APS02244) was transferred to Rajeev Gandhi Rural Education & Multipurpose Trust, Koppal, which is running the institution in the name of Rajeev Gandhi rural Education College Education (B.Ed) at R.D.T.E. building, near Dadegal, Gadag Road, Koppal 583231. On enquiry, it is found that the transfer was affected without taking approval from NCTE. The College of Education is being run in a building where Diploma College, M.Com, NSW, & BSW courses are also run by another management. Presently the premise is used by two trusts for different courses.
- Rajeev Gandhi Rural College of Education (B.Ed) at R.D.T.E building, Near Dadegal, Gadag Road, Koppal-583231 is being run without any grant of recognition from NCTE. This is a gross violation of NCTE rules and regulations.

AND WHEREAS, a show cause notice was issued to the institution on 21.08.2014. The institution (Rajiv Gandhi Rural Education Trust) submitted its written representation on 12.11.2014.

AND WHEREAS, the SRC in its 275th meeting held on 1-2 December 2014 considered the matter and decided to await notification of the new Regulation. Put up in the next meeting.

AND WHEREAS, an email dated 18.12.2014 received from NCTE Hqrs regarding guidance for processing of pending applications. Accordingly a willingness letter was issued to the institution on 19.12.2014.

AND WHEREAS, the institution (Rajeevagandhi College) submitted its written representation on 31.12.2014 for both M.Ed and B.Ed course on 31.12.2014 along with affidavits for each course.

AND WHEREAS, the SRC in its 276th meeting held during07th – 09th July, 2015 considered the matter, reply of the Institution dated 29.12.2014 along with affidavit

expressing their willingness to process their application as per Regulations 2014, decided that:

 Sl.no. 77 (APS02244) & 78 (APS08822) relate to the same institution. The basic issue is about change of 'Vinootan' name to 'Rajeev Gandhi'. We do not have the application they claim to have sent. Advised SRO to ask them to apply formally for change of name.

2. For M.Ed (Basic Unit) now NAAC certificate is not required. Let us not pursue

the Show Cause Notice.

- 3. Affidavits have been received.
- 4. Issue revised Provisional recognition order requiring them to comply with the 2014 Regulations before 31.10.2015.
- 5. Verify in October.
- 6. Inspect subsequently.

AND WHEREAS, as per decision of SRC a letter was issued to the institution on 30.01.2015 (P-263/C).

AND WHEREAS, on 19.01.2015 the institution submitted the affidavit for offering course with an intake of 100 students. The Revised Order was issued to the institution on 20.05.2015 with an intake of 100 students two basic units of 50 each.

AND WHEREAS, on 30.07.2015 the institution has submitted a letter with a request regarding change of the name of the institution (Gramina Shikshana Mahavidyalay B.Ed College, Koppal from Vinootana Samste Alwandi, Tq. & Dist, Koppal to Rajeev Gandhi Rural Education and Multipurpose Trust (R), Koppal.

AND WHEREAS, the institution has submitted revised order reply on 30.07.2015.

AND WHEREAS, the SRC, in its 315th meeting held during 17th to 18th June, 2016 considered the reply to the revised order-submission of documents and decided as under:-

- "1. B.Ed (2 units) was sanctioned in favour of Vinootan Shikshana Seva Samsthe. At the time of applying for M.Ed (1unit) by Rajeev Ghandhi Rural Education Trust the B.Ed College was also handed over to them. They have now properties and courses.
 - 2. Title -deeds have been duly amended. The State Govt. has formally approved.
 - 3. All the formalities prescribed by NCTE have been completed.
- 4. Change of Society's name and management from Vinootan Shikshana Seva Samsthe to Rejeev Gandhi Rural Education Trust is permitted.

- 5. (i). EC shows that the lands are mortgaged to central Bank of India.
 - (ii). BP is not approved by competent authority.
 - (iii). BCC and original FDRs are not given.
 - (iv). Inspection fee not paid
- 6. Issue Show Cause Notice accordingly.

AND WHEREAS, as per decision of SRC a show cause notice was issued to the institution on 27.06.2016.

But, till date the institution has not submitted show cause notice reply.

AND WHEREAS, the SRC in its 322nd meeting held on 20th& 21st October, 2016 considered the Non-submission of SCN reply and decided as under:-

- 1. This case is linked to the M.Ed case APS08822 at Sl.No.5 2.
- 2. Put up the 2 cases together in the next meeting.

AND WHEREAS, as per the decision of SRC, the documents in both the cases are processed as under:

AND WHEREAS, the matter was considered by the SRC in its 376th meeting held from 11th & 12th June 2019 and the Committee decided as under:-

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

The Committee decided to issue Show Cause Notice u/s 17 of NCTE Act, 1993 before withdrawal of the recognition on the following grounds:-

- The institution is required to submit certified copy of land documents. (If the same are in Regional Language the institution is also required to submit notarised copy of English version of land documents)
- 2. Land Use Certificate issued by the Competent Authority.
- 3. Non Encumbrance Certificate issued by the Competent Authority.
- 4. A copy of the approved Building Plan (if institution is running more than one Teacher Education programme, it shall be required to submit an exclusive earmarked building plan for each of the recognised Teacher Education programme)
- 5. Details of Teacher Education programme/other programme (if any) being run by the institution in the same campus

- 6. Building Completion Certificate as per prescribed Format.
- 7. Staff list duly approved by the affiliating body as per the prescribed Format.
- 8. Original FDR of Rs.7 lakh and 5 lakh, totalling Rs.12 lakh towards Endowment Fund & Reserve Fund into joint account for a duration of 5 years.

In view of above, the Committee decided that Show Cause Notice be issued to the institution as to why the recognition be not withdrawn on the above points. The Committee, therefore, provides last opportunity under Section 17 of the NCTE Act, 1993 to the institution to submit its reply within 21 days from the date of issue of notice, before the Committee takes the final decision. In case, the office does not receive any representation within stipulated time, it will be presumed that the institution does not wish to make any representation, and the Southern Regional Committee shall take decision as per provisions of the NCTE Act, Rules and Regulations.
