Show Cause Notice

WHEREAS, Janata Shikshana Samiti, Dharwad District – 580004, Karnataka had submitted an application to the Southern Regional Committee of NCTE for grant of recognition to J.S.S. Sri. Manjunatheshwara College of Education, Vidyagiri, Dharwad- 580004, Karnataka for Secondary (B.Ed) course of one year duration with an annual intake of 100 students and was granted recognition on 10.08.2007.

AND WHEREAS, on 30.01.2015, the institution submitted the affidavit for offering B.Ed course with an intake of 100 students. Accordingly, a Provisional Revised Recognition Order was issued to the institution for conducting B.Ed programme of two years duration with an annual intake of 100 for two basic units of 50 students each from the academic session 2015-16 on 31.05.2015.

AND WHEREAS, on 31.03.2015, the institution submitted a letter regarding request for changing the nomenclature of our JSS College of Education into JSS Shri ManjuNatheshwara College of Education, Dharwad.

AND WHEREAS, the SRC in its 284th meeting held during 09th - 10th April, 2015 considered the request of the institution and decided to process. Accordingly, the application was processed. The request for change of name of the institution was considered and agreed. Accordingly, a corrigendum was issued to the institution on 21.07.2015 for change of name of the institution. The institution has submitted revised order reply on 03.11.2015, 02.03.2016, 26.05.2016, 28.5.2018.

AND WHEREAS, SRC in its 314th meeting held during 27th to 28th May 2016 considered the matter of institution which have been given recognition for offering with an intake of 100 students and authorized the RD to initiate VT inspection accordingly.

AND WHEREAS, as per the decision of SRC, a letter to the institution was issued on 13.06.2016. The institution submitted inspection fees of Rs. 1, 50,000/- vide DD No - 557834 dated 04.07.2016. Accordingly, Inspection of the institution was conducted on 21.10.2016 and the VT report along with documents received on 24.10.2016.

AND WHEREAS, the SRC in its 351st meeting held during 28th - 29th December, 2017considered the VT report and decided as under:-

- "1. This is a RPRO case of B.Ed (2units).
- 2.1. The title position is very unclear. There is a mention of a government lease. But the lease was only for 5 years. And, the lease period was from 1970 to 1975! Also, there is a mention of 'mortgage' of the land to the Syndicate Bank. The EC shows it as 'purchase by the Syndicate Bank'.
- 2.2. They must explain the land/title position.
- 3.1. LUC is in order.
- 3.2 EC is in order. Shows mortgage / sale of the property.
- 4.1. BP is in the name of a School Project. The built-up area shown is only 455 sq.mt.
- 4.2. BCC is not in format. Not in original; only a photocopy. Does not show the built-up area.
- 5. FDRs are in order.
- 6. Faculty list is not authenticated on all pages for B.Ed (2 units).
- 7. Issue SCN accordingly."

AND WHEREAS, as per the decision of SRC Show Cause Notice was issue to the institution on 05.01.2018.

AND WHEREAS, the institution has submitted Show Cause Notice reply on 30.01.2018, 1.2.2018, 3.5.2018 and on 14.1.2019.

AND WHEREAS, the matter was considered by the SRC in its 376th meeting held from 11th & 12th June 2019 and the Committee decided as under:-

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

The Committee decided to issue **Show Cause Notice u/s 17 of NCTE Act**, 1993 before withdrawal of the recognition on the following grounds:-

Latest Staff list duly approved by the affiliating university as per the prescribed Format

In view of above, the Committee decided that Show Cause Notice be issued to the institution as to why the recognition be not withdrawn on the above points. The Committee, therefore, provides last opportunity under Section 17 of the NCTE Act, 1993 to the institution to submit its reply within 21 days from the date of issue of notice, before the Committee takes the final decision. In case, the office does not receive any representation within stipulated time, it will be presumed that the institution does not wish to make any representation, and the Southern Regional Committee shall take decision as per provisions of the NCTE Act, Rules and Regulations.
