WITHDRAWAL ORDER

WHEREAS, National Educational Society, Shimoga District, Karnataka had submitted an application to the Southern Regional Committee of NCTE for grant of recognition to General Kariyappa Rastriya Dhyhika Shikshana Mahavidhyalaya, Balraj Urs Road, Shimoga District-577201, Karnataka for (B.P.Ed) course of one year duration with an annual intake of 50 students and was granted recognition on 19.03.2008.

AND WHEREAS, on 23.01.2015, an affidavit from the Principal, General Cariappa Rastriya Daihika Shikshana Mahavidhyalaya, Balraj Urs Road, Shimoga District-577201, Karnataka dated 20.01.2015, was received by this office regarding submission of affidavit based on the revised norms of Regulations, 2014.

AND WHEREAS, the provisional revised order was issued to the institution on 20.05.2015. The Institution has submitted a written representation on 18.02.2016.

AND WHEREAS, the matter of the institution was placed in the 321th meeting of SRC held on 28th & 30th September 2016 and decided as under:

"We should use this opportunity to verify the basic facts with respect to documents in all such RPRO cases many of which relate to very old FRs issued by us R.D. may collect -Land deeds; LUC; EC; BP; BCC; FDRs; and Faculty Lists and get them processed by office so that we can critically scrutinize the facts and take appropriate decisions about issue of new FRSs."

AND WHEREAS, a letter was issued to the institution on 15.10.2016.

AND WHEREAS, on 13.12.2017, a letter was received by this office from the institution for closure is as under: -

"Whereas this office wrote a letter on the basis of the resolution of the National Education Society, Executive Committee dated 02.02.2017 to the Registrar, Kuvempu University that the admissions to General Kariyappa College of Physical Education shall not be made during the academic year 2017-18. Because the admission to the said college had dwindled after NCTE, instructed to start two year course for B.P.Ed courses and it was financially not viable for running the course.

The college development council of Kuvempu University has sent a proposal to the principal secretary department of Education government of the Karnataka under the provisions of the University act 2000 in their letter under Reference (2) for closure of said college.

The CDC Kuvempu University in another letter dated: 30.01.2017 has directed the secretary to NES to seek approval of NCTE for closure of the said college under NCTE regulation 3(e). (Reference-3)

Now it is requested that permission may kindly be accorded to close the institution General Kariyappa College of Physical Education."

AND WHEREAS, a letter was issued to the institution on 22.02.2018 as under:

"With reference to the subject cited above, it is to inform that for closure of the programme being offered in your institution, you are required to submit the application along with required documents for taking necessary action in the matter. The application is available in the SRC NCTE website (i.e.www.srcncte.in)."

AND WHEREAS, the institution has not submitted reply till date.

AND WHEREAS, the matter was considered by the SRC in its 376th meeting held from 11th -12th June, 2019 and the Committee decided to withdraw recognition granted to General Kariyappa Rastriya Dhyhika Shikshana Mahavidhyalaya, Balraj Urs Road, Shimoga District-577201, Karnataka for conducting B.P.Ed. course w.e.f. the academic session 2019-20 under clause 17(1) of NCTE Act, 1993 on the request of the institution. However, the Reserve Fund and Endowment Fund will be refunded by the Regional Director on the submission of the following:

- (a) NOC from the affiliating body.
- (b) NOC from the staff/faculty.
- (c) Resolution of the management to the effect for closure of the course.

NOW, THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to General Kariyappa Rastriya Dhyhika Shikshana Mahavidhyalaya, Balraj Urs Road, Shimoga District-577201, Karnataka run by National Education Society, Shimoga District-577201, Karnataka for B.P.Ed course from the end of the academic session as per provision of NCTE Act on the grounds mentioned above.

Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website http://ncte.gov.in within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
