FINAL SHOW CAUSE NOTICE U/S 17

WHEREAS, the Southern Regional Committee granted recognition to Sultan-UI-Uloom Educational Society for the following courses as per details given below:-

1. The SRC vide order No.F.AP/B.Ed/AI/SRO/NCTE/2000-2001/3129 dated 09.01.2001 grants recognition to **Gulam Ahmed College of Education, Mount Pleasant, 8-2-249, Banjara Hills, Road No.3, Hyderabad-500034, Andhra Pradesh** for B.Ed course of one year duration for the academic session 2000-2001 with an annual intake of 84 students. The SRC vide order No.F.No./SRC/NCTE/APSO0191/B.Ed/AP/2015/65828 dated 29.05.2015 issued RPRO to the institution.
2. The SRC vide order No.F.AP/M.Ed/New/04/SRO/NCTE/2000-2001/8704 dated 19.11.2001 grants recognition to **Gulam Ahmed College of Education, "Mount Pleasant", 8-2-249, Road No.3, Banjara Hills, Hyderabad-500034, Andhra Pradesh** for M.Ed course of one year duration for the academic session 2001-2002 with an annual intake of 20 students. The SRC vide order No.F.No./SRC/NCTE/APSO0028/M.Ed/AP/2015/69423 dated 06.07.2015 issued RPRO to the institution.
3. The SRC vide order No.F.SRC/NCTE/D.Ed/2005-2006/2625 dated 26.08.2005 grants recognition to **Gulam Ahmed Elementary Teacher Education College, No.8-2-249, Road No.3, Banjara Hills, Hyderabad-500034, Andhra Pradesh** for Elementary (D.Ed) course of two years duration for the academic session 2005-2006 with an annual intake of 50 students.

2. AND WHEREAS, the SRC received a letter No. Ins 012/35/2017-Complaint Section - Hq/67478 dated 25th June, 2018 regarding complaint against land documents of the Institution and the SRC in its 368th meeting held on 08th & 09th January, 2019 considered the matter and decided as under;

1. This is an old case in which they were running D.El.Ed. (1 unit), B.Ed. (1 Unit of 100) M.Ed. (1 Unit).
2. The case came to light in the course of our giving them an RPRO for B.Ed. (2 Units).
3. Issues like inadequate built-up area, inadequate instructional facility, deficient FDRs, unclear title to land, etc. emerged for scrutiny.
4. There was also a spate of litigation because of internal squabbles within the Trust over title to lands and buildings.

- 5.1 The SRC withdrew recognition given to all the three courses even as it halted the RPRO proceedings.
- 5.2 The operation of this order was suspended by the Court. And the programmes have been continuing on that basis.
- 6 We have now to clarify all the issues relating to all the 3 programmes besides reviving the RPRO case for B.Ed. (2 Units of 50 each) under the 2014 Regulations.
- 7 SRO should now reopen all the three cases and examine case wise all the issues: title to land, LUC, EC, BP, BCC, FDRs and, Faculty Lists.
- 8 If all the issues are satisfied according to the 2014 Regulations, we can reconfirm the FR for D.El.Ed. (1 Unit), for M.Ed. (1 Unit) and, issue a regular new FR for B.Ed. (2 Units) under the 2014 Regulations.
- 9 Please process accordingly and resubmit in the 370th meeting.

3. **AND WHEREAS**, the case was again resubmitted before the SRC and the SRC in its 373rd meeting held on 26th & 27th March, 2019 considered the matter and decided as under;

The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

The matter pertaining to Ghulam Ahmed College of Elementary Education, 8-2-249, Mount Pleasant Road No-3, Banjara Hills, Hyderabad-500034, Andhra Pradesh was discussed and it was decided to serve a Show Cause Notice asking the Management to furnish the legality of the land documents, latest staff list, status of FDRs and building plan exclusive for teacher education programme.

4. **AND WHEREAS**, as per the decision of SRC a show cause notice was issued to the institution on 08.04.2019. The institution vide letter dated 23.04.2019 submitted its reply to the show cause notice. The SRC in its 377th meeting held on 03rd – 04th July, 2019 considered the matter and decided as under;

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

- (i) The Committee discussed the reply submitted by the Institution in detail and decided to wait till the final disposal of the case by the Hon'ble Court regarding the land dispute.

In addition to the above, the Committee also observed the following deficiencies, therefore, the institution is required to submit its reply in the matter and also required to submit the following documents:-

1. The institution has not submitted a copy of approved building plan. The institution is required to submit a attested/notarised copy of the approved Building Plan (if institution is running more than one Teacher Education programme, it shall be

- required to submit an exclusive earmarked building plan for each of the recognised Teacher Education programme)
2. The institution has not submitted a copy of Building Completion Certificate. The Institution is required to submit an attested/notarised copy of Building Completion Certificate issued by the competent authority.
 3. The institution has not submitted Staff list as per the prescribed Format duly approved by Registrar of the affiliating body. The institution is required to submit Staff list duly approved by the Registrar of the affiliating body as per the prescribed Format. *(In case the institution is running more than one teacher education programme, it is required to submit staff list duly approved by the Affiliating body for each of the recognised teacher education programme being run by the Institution.)*
 4. The institution has not submitted original FDRs to the SRC, NCTE The institution is required to submit a "Form A" issued by the respective Bank Manger towards creation of FDR of Rs.7 lakh and 5 lakh, totalling Rs.12 lakh towards Endowment Fund & Reserve Fund into joint account for a duration of 5 years alongwith a copy of the FDRs
 5. Details of Teacher Education programme (s) being run by the Institution in the same campus

8. Domain name of the website being run by the institution.

Therefore, the Committee decided to issue Final Show Cause Notice u/s 17 of NCTE Act, 1993 before withdrawal of the recognition on the grounds mentioned above to the institution. The institution is required to submit the documents within 21 days from the date of issue of Final Show Cause Notice.

5. Accordingly, the Southern Regional Committee decided that a Final Show Cause Notice u/s 17 of the NCTE Act issued to the institution to submit its representation/reply to the observations noted by the Regional Committee

6. **NOW, THEREFORE**, the institution is required to submit the representation/compliance accompanied with an affidavit from the authorized representation of the Management. The representation along with an affidavit must reach this office within the time specified at the end.

7. In case the reply submitted is incomplete or factually incorrect or not received in this office by the date mentioned at the end of this letter, then proceedings under Section 17(1) of the NCTE Act shall be brought to logical conclusion without any further opportunity provided in the matter whatsoever.

8. It is expected that your reply shall reach this office through Courier/Registered AD/Speed Post only. NCTE does not expect applicants to personally visit the RC Office for any reason whatsoever.

9. Your reply, complete in all respects must reach this office on or before **30.07.2019**.
