Final Show cause notice u/s 17 of the NCTE, 1993

Whereas, the institution namely Euphraisia Training College, Provincial Superior, Udaya Provincial House, Irinjalakuda-680125, Thrissur District, Kerala was granted recognition vide SRC (NCTE) order no. F.KL/SEC/N/167/SRO/NCTE/2004-2005/775 dt. 23.02.2005 for conducting B.Ed. course of one-year duration with an annual intake of 100 students from the academic session 2006-2007.

And whereas, a provisional revised recognition order dt. 15.05.2015 was issued to the institution for conducting B.Ed. course of two years' duration with an annual intake of 100 (two basic units) from the academic session 2015-16 subject to the following conditions:-

(i) The institution shall submit revalidated FDRs of the enhanced values, in joint account with the SRC before 30th June, 2015 failing which the recognition will be withdrawn.

And whereas, the institution has submitted its compliance, for conditions stipulated in provisional revised recognition order, vide letters dt.03.04.2019 & dt.07.06.2019.

And whereas, the *reply letters dt.03.04.2019* & *dt.07.06.2019* of the institution along with regulatory file was placed before the SRC in its 377th meeting held on 03rd – 04th July, 2019 and the Committee decided to issue show cause notice u/s 17 (1) of the NCTE Act, 1993 on the following points:

"The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

1. The institution has not submitted a certified copy of land documents. The institution is required to submit certified copy of land documents issued by concerned Tehsildar /Revenue Officer. (If the same are in Regional Language the institution is also required to submit notarised copy of English version of land documents)

2. The institution has not submitted a copy of Land Use Certificate. The institution is required to submit an attested/notarised copy of Land Use

Certificate issued by the Competent Authority.

3. The institution has not submitted a copy of Non Encumbrance Certificate issued by the Competent Authority. The institution is required to submit a attested/notarised copy of Non Encumbrance Certificate issued by the

Competent Authority.

4. The institution has not submitted a copy of approved building plan. The institution is required to submit a attested/notarised copy of the approved Building Plan (if institution is running more than one Teacher Education programme, it shall be required to submit an exclusive earmarked building plan for each of the recognised Teacher Education programme)

6. The institution has not submitted a copy of Building Completion Certificate.

The Institution is required to submit an attested/notarised copy of Building

Completion Certificate issued by the competent authority.

7. The institution has not submitted Staff list as per the prescribed Format duly approved by Registrar of the affiliating body. The institution is required to submit Staff list duly approved by the Registrar of the affiliating body as per the prescribed Format. (In case the institution is running more than one teacher education programme, it is required to submit staff list duly approved by the Affiliating body for each of the recognised teacher education programme being run by the Institution.)

8. The institution has not submitted original FDRs to the SRC, NCTE The institution is required to submit a "Form A" issued by the respective Bank Manger towards creation of FDR of Rs.7 lakh and 5 lakh, totalling Rs.12 lakh towards Endowment Fund & Reserve Fund into joint account for a duration of

5 years alogwith a copy of the FDRs

Now therefore, in compliance of the decision of the SRC this show cause notice (SCN) is issued u/s 17 (1) of NCTE Act, 1993 with the direction to submit your written representation with a period of 21 days from the date of issue of this notice, complying the decision of the SRC, failing which action u/s 17(1) will be taken as per NCTE Act & Regulations 2014.

You are also directed that if any document is in regional language, the Notarized English translation be also submitted.

In case, the office does not receive any representation within the stipulated time, it will be presumed that the institution does not wish to make any representation, and the Southern Regional Committee shall take decision as per provisions of the NCTE Act and Regulations.
