ORDER

WHEREAS, recognition was granted to the institution namely Dr. M.G.R. Educational & Research Institute, Periyar E.V.R. High Road (NH 4 Highway), Maduravoyal, Chennai – 600095, Tamilnadu vide SRC (NCTE) order no. F.TN/SEC/SRO/NCTE/2005-06/4064 dt.17.11.2005 for conducting B.Ed. course of one year' duration from the academic session 2005-06.

2. AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dated 19.01.2015 for its willingness for adherence of provisions of new Regulations.

3. AND WHEREAS, a Revised Provisional Recognition Order No. F.SRO/NCTE/APSO1358/B.Ed./TN/2015-16/65679 was issued to the institution on 27.05.2015 for conducting B.Ed. course of two years' duration with an annual intake of 100 two basic units of 50 students each from the academic session 2015-16.

4. AND WHEREAS, an Order No. F.No.SRO/NCTE/APSO1358/B.Ed./TN/2017-18/94591 dt. 01.09.2017 was issued to the institution, for conducting B.Ed course with an intake of 50 students.

5. AND WHEREAS, as per the decision of SRC in its 369<sup>th</sup> meeting held on 28<sup>th</sup> January, 2019, a show cause notice was issued to the institution on 01.05.2019. The institution vide letters dated 17.05.2019 & 07.06.2019 submitted its reply to the show cause notice. The SRC in its 377<sup>th</sup> meeting held on 03<sup>rd</sup> – 04<sup>th</sup> July, 2019 considered the matter and decided as under;

*On the perusal of the reply furnished by the institution, the Committee decided that Order for Continuance of recognition of B.Ed. course with an annual intake of 50 of one basic unit, be issued to the institution.*

6. NOW THEREFORE, this order is issued permitting the institution i.e. Dr. M.G.R. Educational & Research Institute, Periyar E.V.R. High Road (NH 4 Highway), Maduravoyal, Chennai – 600095, Tamilnadu for continuation of conducting for B.Ed. course of two-year duration with an intake of 50 students (one unit). The institution shall maintain the following:

1. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provision of Section 17(1) of the NCTE Act, 1993.

Also order that a copy of this Order be published in the official Gazette.

- II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
  - III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
  - IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
7. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, the State Government etc. as applicable.
8. The institution shall submit to the Regional Committee a Self – Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
9. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter – alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely: -
- a. *Sanctioned programme(s) along with annual intake in the institution;*
  - b. *Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.*
  - c. *Name of faculty members who left or joined during the last quarter;*
  - d. *Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;*
  - e. *Fee charged from students;*
  - f. *Available infrastructural facilities;*
  - g. *Facilities added during the last quarter;*
  - h. *Number of books in the library, journals subscribed to and additions, if any, in the last quarter;*
  - i. *The affidavit with enclosure submitted along with application.*
  - j. *The institution shall be free to post additional relevant information, if it so desires.*
  - k. *Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.*
10. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
11. The institution shall make available the list of students admitted on its official website.
12. The institution shall fill the information on GIS Portal on the NCTE Website.
