FINAL SHOW CAUSE NOTICE U/S 17

WHEREAS, recognition was granted by the Southern Regional Committee to Anjanadevi B.Ed College, C/o S.H. Patil ITI College, Shed C-7, Industrial Area, Near Water Tank, Banjari Kallur Road, Humnabad-585330, Bidar District, Karnataka vide Order No.F.SRO/NCTE/B.Ed/2004-2005/9090 date 02.12.2004 for B.Ed Course of one Years duration with an annual intake of one unit(s) of 100 students.

- **2. AND WHEREAS**, after promulgation of NCTE Regulations, 2014, the institution by a notarized affidavit dated 19.01.2015 consented to come under new Regulations.
- 3. AND WHEREAS, the Southern Regional Committee (NCTE) issued the revised provisional recognition order dated 16.05.2015to Anjanadevi B.Ed College, C/o S.H. Patil ITI College, Shed C-7, Industrial Area, BanjaruKallur Road, 585330, Karnataka for conducting B.Ed. course of two years duration with an annual intake of 100 students [two basic unit(s) of 50 students each] from the academic session 2015-2016 subject to fulfilment of conditions mentioned therein. A corrigendum dated 01.07.2015 was issued to the institution permitting the institution to have one basic unit of 50 students.
- **4. AND WHEREAS**, as per the decision of the Southern Regional Committee in its 369th Meeting held on dated 28.1.2019 a Show Cause Notice u/s 17 was issued on the institution on following grounds with a direction to submit the reply to this second Show Cause Notice on or before 20.3.2019.
- **5. AND WHEREAS** the institution submitted its reply vide letter dated 27.3.2019 and the Committee in its 377th meeting held on dated 3rd & 4th July,2019 decided that the following points must be responded:-

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

 The institution has not submitted a certified copy of land documents. The institution is required to submit certified copy of land documents issued by concerned Tehsildar /Revenue Officer. (If the same are in Regional Language the institution is also required to submit notarised copy of English version of land documents)

7. The institution has not submitted Staff list as per the prescribed Format duly the affiliating body. The institution is required to approved by Registrar of submit Staff list duly approved by the Registrar of the affiliating body as per the prescribed Format. (In case the institution is running more than one teacher education programme, it is required to submit staff list duly approved by the Affiliating body for each of the recognised teacher education programme being run by the Institution.)

8. The institution has not submitted original FDRs to the SRC, NCTE The institution is required to submit a "Form A" issued by the respective Bank Manger towards creation of FDR of Rs.7 lakh and 5 lakh, totalling Rs.12 lakh towards Endowment Fund & Reserve Fund into joint account for a duration of 5 years alogwith a copy

- 6. Accordingly, the Southern Regional Committee decided that a Final Show Cause Notice u/s 17 of the NCTE Act issued to the institution to submit its representation/reply to the observations noted by the Regional Committee
- 7. NOW, THEREFORE, the institution is required to submit the representation/compliance accompanied with an affidavit from the authorized representation of the Management. The representation along with an affidavit must reach this office within the time specified at the end.
- 8. In case the reply submitted is incomplete of factually incorrect of not received in this office by the date mentioned at the end of this letter, then proceedings under Section 17(1) of the NCTE Act shall be brought to logical conclusion without any further opportunity provided in the matter whatsoever.
- 9. It is expected that your reply shall reach this office through Courier/Registered AD/ Speed Post only. NCTE does not expect applicants to personally visit the RC Office for any reason whatsoever.
- 10. Your reply, complete in all respects must reach this office within 21 days of issue of this Final Show Cause Notice.
