## **Final Show Cause Notice**

The following intuitions are being run by Noor Educational Trust, Bidar, Karnataka as per details given details below:-

- (i) Noor College of Education, Noor Colony, Near orticulture Centre, Haladkeri, Hyderabad Road, Bidar 585401, Karnataka run by Noor Educational Trust, Bidar, Karnataka was granted recognition for B.Ed course of one year duration from the academic session 2005-2006 with an annual intake of 100 students on 03.01.2006. Subsequently, the institution was issued RPRO order dated 26.05.2015 vide order No.F.SRO/NCTE/APSO1858/B.Ed/KA/2015-16/65592 an annual intake of 100 for two basic units of 50 students each from the academic session 2015-16.
- (ii) Noor M.Ed College, Noor Colony Near Horiculture Centre, Haladkeri, Hyderabad Road, Bidar District 585401, Karnataka vide Order No F.SRO/NCTE/M.Ed/2006-2007/15255 date 22.11.2007 for M.Ed Course of one year duration with an annual intake 25 students. The enhancement of intake of 10 seats from existing 25 to 35 was permitted to Noor M.Ed College, Noor Colony Horiculture Centre, Haladkeri, Hyderabad Road, Bidar District 585401. Subsequently, the institution was issued RPRO order dated 01.07.2015 vide order No. F.SRO/NCTE/APSO08550/M.Ed/KA/2015/69075 an annual intake of 50 students (one unit) from the academic session 2015-16.
- 2. AND WHEREAS, the matter regarding compliance by the institutions of the conditions of the revised recognition order was placed before the SRC in its 369<sup>th</sup> meeting held on 28.01.2019 and Committee decided that Show Cause Notice be issued to all such institutions which have not submitted compliance.
- 3. AND WHEREAS, a show cause notice dated 12.02.2019 was issued to the institution on in respect of the M.Ed. programme being run by the Institution. The institution submitted its reply vide letter dated 14.03.2019.
- **4. AND WHEREAS**, the cases pertaining to B.Ed & M.Ed programme being run by the Institution were placed before the SRC in its 377<sup>th</sup> meeting held from 3<sup>rd</sup> July & 4<sup>th</sup> July 2019 and the Committee decided as under:-

- 1. The institution has not submitted a certified copy of land documents. The institution is required to submit certified copy of land documents issued by concerned Tehsildar /Revenue Officer. (If the same are in Regional Language the institution is also required to submit notarised copy of English version of land documents)
- 2. The institution has not submitted a copy of Land Use Certificate. The institution is required to submit an attested/notarised copy of Land Use Certificate issued by the Competent Authority.
- 3. The institution has not submitted a copy of Non Encumbrance Certificate issued by the Competent Authority. The institution is required to submit a attested/notarised copy of Non Encumbrance Certificate issued by the Competent Authority.
- 4. The institution has not submitted a copy of approved building plan. The institution is required to submit a attested/notarised copy of the approved Building Plan (if institution is running more than one Teacher Education programme, it shall be required to submit an exclusive earmarked building plan for each of the recognised Teacher Education programme)
- 5. A attested/notarised copy of site plan showing all the plot/Survey No. mentioned in the land documents in one location alongwith land area and built up area.
- 6. The institution has not submitted a copy of Building Completion Certificate. The Institution is required to submit an attested/notarised copy of Building Completion Certificate issued by the competent authority.
- 7. The institution has not submitted Staff list as per the prescribed Format duly approved by Registrar of the affiliating body. The institution is required to submit Staff list duly approved by the Registrar of the affiliating body as per the prescribed Format. (In case the institution is running more than one teacher education programme, it is required to submit staff list duly approved by the Affiliating body for each of the recognised teacher education programme being run by the Institution.)
- 8. The institution has not submitted original FDRs to the SRC, NCTE The institution is required to submit a "Form A" issued by the respective Bank Manager towards creation of FDR of Rs.7 lakh and 5 lakh, totalling Rs.12 lakh towards Endowment Fund & Reserve Fund into joint account for a duration of 5 years alogwith a copy of the FDRs

Therefore, the Committee decided to issue Final Show Cause Notice u/s 17 of NCTE Act, 1993 before withdrawal of the recognition on the grounds mentioned above to the institution. The institution is required to submit the documents within 21 days from the date of issue of Final Show Cause Notice."

- 5. Accordingly, the Southern Regional Committee decided that a Final Show Cause Notice u/s 17 of the NCTE Act issued to the institution to submit its representation/reply to the observations noted by the Regional Committee
- 6. **NOW, THEREFORE**, the institution is required to submit the representation/compliance accompanied with an affidavit from the authorized representation of the Management. The representation along with an affidavit must reach this office within the time specified at the end.
- 7. In case the reply submitted is incomplete of factually incorrect of not received in this office by the date mentioned at the end of this letter, then proceedings under Section 17(1) of the NCTE Act shall be brought to logical conclusion without any further opportunity provided in the matter whatsoever.
- 8. It is expected that your reply shall reach this office through Courier/Registered AD/ Speed Post only. NCTE does not expect applicants to personally visit the RC Office for any reason whatsoever.
- Your reply, complete in all respects must reach this office within 21 days of issue of this <u>Final Show Cause Notice.</u>
