## FINAL SHOW CAUSE NOTICE U/S 17

WHEREAS, recognition was granted by the Southern Regional Committee to Subramanya College of Education, No. 63, BEL Layout, Viswaneedam Post Off. Magadi Road, Bangalore, Karnataka - 560091 vide Order No F.SRO/NCTE/B.Ed/2004-2005 date 24.12.2004 for B.Ed Course of one year's duration with an annual intake of one unit(s) of 100 students.

- AND WHEREAS, on promulgation of NCTE Regulations 2014 the institution by a notarized affidavit dated 05.06.2015 consented to come under new Regulations and sought for two basic units of 50 students each of two years B.Ed. course.
- AND WHEREAS, revised provisional recognition order dt. 31.10.2015 was issued to Subramanya College of Education, No. 63, BEL Layout, Vishwaneedam Post Off. Magadi Road, Bangalore, Karnataka - 560091 for conducting B.Ed. course of two years duration with an annual intake of two basic units of 50 students each from the academic session 2015-2016 subject to fulfillment of the conditions mentioned in the revised order.
- AND WHEREAS, as per the decision of the Southern Regional Committee in its 369th 4. Meeting held on 28.01.2019 a Show Cause Notice u/s 17 was issued on the institution on following grounds with a direction to submit the reply to this second Show Cause Notice on or before 18.02.2019.
- AND WHEREAS, the institution not submitted its reply and the Committee in its 377th meeting held on 3<sup>rd</sup> & 4<sup>th</sup> July,2019 decided that the following points must be responded:-

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

1. The institution has not submitted a certified copy of land documents. institution is required to submit certified copy of land documents issued by concerned Tehsildar /Revenue Officer. (If the same are in Regional Language the institution is also required to submit notarised copy of English version of land documents)

2. The institution has not submitted a copy of Land Use Certificate. The institution is required to submit an attested/notarised copy of Land Use Certificate issued by

the Competent Authority.

- 3. The institution has not submitted a copy of Non Encumbrance Certificate issued by the Competent Authority. The institution is required to submit a attested/notarised copy of Non Encumbrance Certificate issued by the Competent Authority.
- 4. The institution has not submitted a copy of approved building plan. The institution is required to submit a attested/notarised copy of the approved Building Plan (if institution is running more than one Teacher Education programme, it shall be required to submit an exclusive earmarked building plan for each of the recognised Teacher Education programme)
- 5. A attested/notarised copy of site plan showing all the plot/Survey No. mentioned in the land documents in one location alongwith land area and built up area.
- 6. The institution has not submitted a copy of Building Completion Certificate. The Institution is required to submit an attested/notarised copy of Building Completion Certificate issued by the competent authority.
- 7. The institution has not submitted Staff list as per the prescribed Format duly approved by Registrar of the affiliating body. The institution is required to submit Staff list duly approved by the Registrar of the affiliating body as per the prescribed Format. (In case the institution is running more than one teacher education programme, it is required to submit staff list duly approved by the Affiliating body for each of the recognised teacher education programme being run by the Institution.)
- 8. The institution has not submitted original FDRs to the SRC, NCTE The institution is required to submit a "Form A" issued by the respective Bank Manger towards creation of FDR of Rs.7 lakh and 5 lakh, totalling Rs.12 lakh towards Endowment Fund & Reserve Fund into joint account for a duration of 5 years alogwith a copy of the FDRs
- 9. Details of Teacher Education programme (s) being run by the Institution in the same campus

Therefore, the Committee decided to issue Final Show Cause Notice u/s 17 of NCTE Act, 1993 before withdrawal of the recognition on the grounds mentioned above to the institution. The institution is required to submit the documents within 21 days from the date of issue of Final Show Cause Notice"

- 6. Accordingly, the Southern Regional Committee decided that a Final Show Cause Notice u/s 17 of the NCTE Act issued to the institution to submit its representation/reply to the observations noted by the Regional Committee
- 7. NOW, THEREFORE, the institution is required to submit the representation/compliance accompanied with an affidavit from the authorized representation of the Management. The representation along with an affidavit must reach this office within the time specified at the end.
- 8. In case the reply submitted is incomplete of factually incorrect of not received in this office by the date mentioned at the end of this letter, then proceedings under Section 17(1) of the NCTE Act shall be brought to logical conclusion without any further opportunity provided in the matter whatsoever.
- 9. It is expected that your reply shall reach this office through Courier/Registered AD/ Speed Post only. NCTE does not expect applicants to personally visit the RC Office for any reason whatsoever.
- 10. Your reply, complete in all respects must reach this office within 21 days of issue of this Final Show Cause Notice.
