WHEREAS, recognition was granted by the Southern Regional Committee to CMM B.Ed College, Mudbi, Basavakalyan -585437, Bidar District, Karnataka vide Order No F.SRO/NCTE/B.Ed/2004-2005/8956 date 30.11.2004 for B.Ed Course of one years duration with an annual intake of one unit(s) of 100students.

- 2. AND WHEREAS, on 31.12.2014 letter was issued to the institution for submission of affidavit expressing adherence to Regulations; 2014. The institution submitted its written representation along with affidavit on 23.06.2015. The Provisional revised order issued to the institution on 01.07.2015 with an intake of 100 students.
- AND WHEREAS, on 09.10.2015 a letter is received by this office from the Correspondent Sri Laxmi Vidya Vardhaka Sangha, Bidar District -585 437, Karnataka regarding request to FDRs withdrawal of interest. A letter issued to the institution on 06.01.2016.
- AND WHEREAS, as per the decision of the Southern Regional Committee in its 321st Meeting held on 28th to 30th September, 2016 a Show Cause Notice dated 14.10,2016 u/s 17 was issued on the institution on following grounds.
 - 1. This is a case of rent-agreement in favour of an individual.
 - 2. LUC & EC are given
 - 3. LUC is not approved by competent authority
 - 4. BP is given.
 - 5. BCC -not given. Built up area is inadequate.
 - 6. Original FDR-not given
 - 7. Approved Faculty list-not given
- AND WHEREAS, the institution not submitted its reply to this SCN. The Committee in its 377th meeting held on 03rd & 04th July, 2019 decided that the following points must be responded:-

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

1. The institution has not submitted a certified copy of land documents. institution is required to submit certified copy of land documents issued by concerned Tehsildar /Revenue Officer. (If the same are in Regional Language the institution is also required to submit notarised copy of English version of land documents)

The institution has not submitted original FDRs to the SRC, NCTE The institution is required to submit a "Form A" issued by the respective Bank Manger towards creation of FDR of Rs.7 lakh and 5 lakh, totalling Rs.12 lakh towards Endowment Fund & Reserve Fund into joint account for a duration of 5 years alogwith a copy

of the FDRs

- 7. Accordingly, the Southern Regional Committee decided that a Final Show Cause Notice u/s 17 of the NCTE Act issued to the institution to submit its representation/reply to the observations noted by the Regional Committee
- 8. **NOW, THEREFORE**, the institution is required to submit the representation/compliance accompanied with an affidavit from the authorized representation of the Management. The representation along with an affidavit must reach this office within the time specified at the end.
- 9. In case the reply submitted is incomplete of factually incorrect of not received in this office by the date mentioned at the end of this letter, then proceedings under Section 17(1) of the NCTE Act shall be brought to logical conclusion without any further opportunity provided in the matter whatsoever.
- 10. It is expected that your reply shall reach this office through Courier/Registered AD/ Speed Post only. NCTE does not expect applicants to personally visit the RC Office for any reason whatsoever.
- 11. Your reply, complete in all respects must reach this office within 21 days of issue of this **Final Show Cause Notice.**
