Final Show Cause Notice

The following intuitions are being run by Indian Education Society, Karnataka as per details given details below:-

- Indian College of Education, Raziya Manzil, Chidri-585403, Bidar District, Karnataka (i) was granted recognition for Secondary B.Ed course of one year duration from the academic session 2004-05 with an annual intake of 100 students and was granted recognition on 02.12.2004. Subsequently, the institution was issued RPRO order dated 18.05.2015 vide order No.F.SRO/NCTE/APSO2435/B.Ed/KA/2014-15/65092 an annual intake of 100 students for two basic units of 50 students each from the academic session 2015-16.
- Indian M.Ed College, Chidri Road, Bidar District 585403, Karnataka was granted (ii) recognition for M.Ed course of one year duration with an annual intake of 25 students and was granted recognition on 22.09.2008. The enhancement of the intake of 10 seats from 25 to 35 is permitted on 24.08.2010 to Indian M.Ed College, Chidri Road, Bidar District - 585403, Karnataka for M.Ed course w.e.f. the session 2010-2011. Subsequently, the institution was issued RPRO order dated 26.05.2015 vide order No.F.SRO/NCTE/APSO7290/M.Ed/KA/2015/65589 an annual intake of 50 students (one unit) from the academic session 2015-16.
- AND WHEREAS, the mater regarding B.Ed. programme being run by the Institution was 2. placed before the SRC in its 318th meeting wherein the SRC decided the following:-
 - 1. Title to land is there (Gift Dee dt. 21.07.2015). Land area (27 guntas of Sy.no.112/1-C) is adequate.
 - 2. LUC/EC-are given.
 - 3. BP is given. BCC-not given.
 - 4. Original FDRs-not given.
 - 5. Faculty list-latest not given.
 - 6. Fee -not paid.
 - 7. Collect fee and cause composite inspection. (B.Ed+M.Ed).
 - 8. Ask VT to collect all relevant documents; and, assess adequacy of facilities, esp. built-up area, for B.Ed (2 units) and M.Ed (1unit).

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

1. The institution is required to submit processing fee of Rs.1.50 (Rs.one lakh fifty thousand

only) towards shifting fee.

2. The institution has not submitted a certified copy of land documents. The institution is required to submit certified copy of land documents issued by concerned Tehsildar /Revenue Officer. (If the same are in Regional Language the institution is also required to submit notarised copy of English version of land documents)

3. The institution has not submitted a copy of Land Use Certificate. The institution is required to submit an attested/notarised copy of Land Use Certificate issued by the

Competent Authority.

4. The institution has not submitted a copy of Non Encumbrance Certificate issued by the Competent Authority. The institution is required to submit a attested/notarised copy of

Non Encumbrance Certificate issued by the Competent Authority.

5. The institution has not submitted a copy of approved building plan. The institution is required to submit a attested/notarised copy of the approved Building Plan (if institution is running more than one Teacher Education programme, it shall be required to submit an exclusive earmarked building plan for each of the recognised Teacher Education programme)

6. A attested/notarised copy of site plan showing all the plot/Survey No. mentioned in the

land documents in one location alongwith land area and built up area.

7. The institution has not submitted a copy of Building Completion Certificate. The Institution is required to submit an attested/notarised copy of Building Completion Certificate issued by the competent authority.

8. The institution has not submitted Staff list as per the prescribed Format duly approved by Registrar of the affiliating body. The institution is required to submit Staff list duly approved by the Registrar of the affiliating body as per the prescribed Format. (In case the institution is running more than one teacher education programme, it is required to submit staff list duly approved by the Affiliating body for each of the recognised teacher education programme being run by the Institution.)

9. The institution has not submitted original FDRs to the SRC, NCTE The institution is required to submit a "Form A" issued by the respective Bank Manger towards creation of FDR of Rs.7 lakh and 5 lakh, totalling Rs.12 lakh towards Endowment Fund & Reserve

Fund into joint account for a duration of 5 years alogwith a copy of the FDRs

- 5. Accordingly, the Southern Regional Committee decided that a Final Show Cause Notice u/s 17 of the NCTE Act issued to the institution to submit its representation/reply to the observations noted by the Regional Committee
- 6. **NOW, THEREFORE**, the institution is required to submit the representation/compliance accompanied with an affidavit from the authorized representation of the Management. The representation along with an affidavit must reach this office within the time specified at the end.
- 7. In case the reply submitted is incomplete of factually incorrect of not received in this office by the date mentioned at the end of this letter, then proceedings under Section 17(1) of the NCTE Act shall be brought to logical conclusion without any further opportunity provided in the matter whatsoever.
- 8. It is expected that your reply shall reach this office through Courier/Registered AD/ Speed Post only. NCTE does not expect applicants to personally visit the RC Office for any reason whatsoever.
- 9. Your reply, complete in all respects must reach this office within 21 days of issue of this **Final Show Cause Notice.**
