## FINAL SHOW CAUSE NOTICE U/S 17

WHEREAS, recognition was granted by the Southern Regional Committee to Government College of Teacher Education, Opp Town Hall, Mangalore 575001, Karnataka vide Order No F.KAR/B.ED/51/SRO/NCTE/2000-2001/1240 date 08.07.2000 for B.Ed Course of one Years duration with an annual intake of one unit(s) of 100 students.

- 2. AND WHEREAS, on promulgation of NCTE Regulations 2014 the institution by a notarized affidavit dated 29.06.2015 consented to come under new Regulations and sought for two basic units of 50 students each of two years B.Ed. course.
- 3. AND WHEREAS, provision revised recognition order dated 03.07.2015 was issued to Government College of Teacher Education, Opp Town Hall, Mangalore 575001, Karnataka for conducting B.Ed. course of two years duration with an annual intake of two basic units of 50 students each from the academic session 2015-2016 subject to fulfillment of the conditions mentioned in the revised order.
- 4. AND WHEREAS, the matter regarding compliance by the institutions of the conditions of the revised recognition order, was placed before the SRC in its 369<sup>th</sup> meeting held on 28.01.2019 and the committee decided that Show Cause Notice be issued to all such institutions which have not submitted compliance. Accordingly, a Show Cause Notice was issued on 14.02.2019.
- 5. AND WHEREAS the institution submitted its reply vide letter dated 11.3.2019 and the Committee in its 377<sup>th</sup> meeting held on dated 3<sup>rd</sup> & 4<sup>th</sup> July, 2019 decided that the following points must be responded:-

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

(i) The institution is required to submit faculty list duly approved by the affiliating body.

Therefore, the Committee decided to issue Final Show Cause Notice u/s 17 of NCTE Act, 1993 before withdrawal of the recognition on the grounds mentioned above to the institution. The institution is required to submit the documents within 21 days from the date of issue of Final Show Cause Notice."
