Final Show Cause Notice

WHEREAS, the recognition was granted to the institution, namely PE Trust's Shankara Gowda College of Education, Mandya-571401 Karnataka run by People's Education Trust for conducting B.Ed. course of one year duration with an intake of 87 students vide order No. F.KAR/B.Ed./59/SRO/NCTE/2000-2001/948 dated 11.07.2000.

- AND WHEREAS, the intake of the institution was increased from 87 to 100 for Secondary course vide order No. F.KR/SEC./SRO/NCTE/2001-02/9331 dated 17.01.2002.
- AND WHEREAS, in exercise of the powers conferred by sub-section (2) of Section 32 of the National Council for Teacher Education Act 1993 (73 of 1993), and in suppression of the National Council for Teacher Education (Recognition Norms and Procedure) Regulations, 2009, the National Council for Teacher Education notified the Regulation, 2014 on 01.12.2014.
- AND WHEREAS, no affidavit has been submitted by the institution as per record available in the file and therefore no revised order was issued to the institution. There is no further action in the file as per records available.
- AND WHEREAS, the matter was considered by the SRC in its 377th meeting held from 3rd July & 4th July 2019 and the Committee decided as under:-

"The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

The institution has not submitted the Affidavit as such the office has (i) not issued any RPRO. In absence of any RPRO you are not supposed to run the programme.

It is construed by the Committee that the institution is not in existence. If there is any grievance you are required to submit all the documents substantiate your case. Otherwise it is deemed that the recognition given to your Institution is withdrawn.

Therefore, the Committee decided to issue Final Show Cause Notice u/s 17 of NCTE Act, 1993 before withdrawal of the recognition on the grounds mentioned above to the institution. The institution is required to submit the documents within 21 days from the date of issue of Final Show Cause Notice."

Accordingly, the Southern Regional Committee decided that a Final Show Cause Notice u/s 17 of the NCTE Act issued to the institution to submit its representation/reply to the observations noted by the Regional Committee.
