Final Show cause notice u/s 17 of the NCTE, 1993

Whereas, the institution namely U.S.P. College of Education, Kodikurichi-Tenkasi Road, Kodikurichi Village, Tenkasi Taluk, Tirunelveli-627804, Tamilnadu was granted recognition vide SRC (NCTE) order no. F.SRO/NCTE/2006-2007/6506 dt. 13.07.2007 for conducting B.Ed. course of one year duration with an annual intake of 100 students from the academic session 2006-2007.

And whereas, a provisional revised recognition order dt. 12.05.2015 was issued to the institution for conducting B.Ed. course of two years' duration with an annual intake of 100 (two basic units) from the academic session 2015-16 subject to the following conditions :-

- (i) The institution shall submit all documents including land, building, encumbrance certificate, land use certificate, building plan, approved staff list, pertaining to shifting to own premises to the SRC before 31st July, 2015 failing which recognition will be withdrawn.
- (ii) The Regional Committees shall inspect the proposed premises during August-September-October, 2015 and if on inspection it is found that the institution does not fulfill required norms of infrastructure recognition will be withdrawn.
- (iii) Further, with regard to the second unit the institution shall create additional facilities that include (a) additional built-up area, (b) additional infrastructure, (c) additional funds, (d) additional staff as per Regulations, 2014 and inform Regional Committee with required documents by October 31, 2015.
- (iv) The applicant-institution for additional unit will be required to submit the required documents such as land documents, Encumbrance Certificate (EC), Land Use Certificate (LUC), Building Plan (BP) and the Approved Staff List in the specified proforma available on the website to the Regional Committee in proof of having provided additional facilities before October 31, 2015. Building Completion Certificate (BCC) may be given along with other documents if available, otherwise it can also be given to the Visiting Team at the time of inspection.
- (v) The Regional Committee shall arrange for verification of documents, inspection of these premises and check adherence to these conditions by 20 February, 2016. If it is found by the Regional Committee that the institution fails to comply with these requirements, the institutions shall not be permitted to admit students for the academic year 2016-2017.

And whereas, the matter of the institution was placed before the SRC in its 315th meeting held during 17th - 18th June, 2016 considered the shifting case and it has decided as under:

1. They have already shifted without NCTE approval.
2. The title deed is in order.
3. Inspection fee not paid.
4. LUC is in order.
5. Obtain latest EC.
6. BCC is not given.
7. BP is given. According to that, the built-up area is adequate only for one unit.
8. Original FDRs not given.

9. Faculty list is not approved and not in format.
10. Collect fee and cause inspection.
11. Ask VT to collect all relevant documents and assess in particular adequacy of built-up area for B.Ed. (2 units) of the 2014 pattern.
12. If the built-up area is not adequate for an intake of 200 (100 + 100) for the 2 new units, we will have to withdraw the recognition given in the RPRO for the 2nd unit.

And whereas, the inspection of the institution was conducted on 13.08.2016.

And whereas, the *reply dt.14.08.2016* of the institution along with regulatory file was placed before the SRC in its 377th meeting held on 03rd – 04th July, 2019 and the Committee decided as under: -

“ The original files of the Institution along with other related documents, NCTE Act, 1993. Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

1. The institution has not submitted a certified copy of land documents. The institution is required to submit certified copy of land documents issued by concerned Tehsildar /Revenue Officer. (If the same are in Regional Language the institution is also required to submit notarised copy of English version of land documents)
2. The institution has not submitted a copy of Land Use Certificate. The institution is required to submit an attested/notarised copy of Land Use Certificate issued by the Competent Authority.
3. The institution has not submitted a copy of Non Encumbrance Certificate issued by the Competent Authority. The institution is required to submit a attested/notarised copy of Non Encumbrance Certificate issued by the Competent Authority.
4. The institution has not submitted a copy of approved building plan. The institution is required to submit a attested/notarised copy of the approved Building Plan (if institution is running more than one Teacher Education programme, it shall be required to submit an exclusive earmarked building plan for each of the recognised Teacher Education programme)
5. A attested/notarised copy of site plan showing all the plot/Survey No. mentioned in the land documents in one location alongwith land area and built up area.
6. The institution has not submitted a copy of Building Completion Certificate. The Institution is required to submit an attested/notarised copy of Building Completion Certificate issued by the competent authority.
7. The institution has not submitted Staff list as per the prescribed Format duly approved by Registrar of the affiliating body. The institution is required to submit Staff list duly approved by the Registrar of the affiliating body as per the prescribed Format. (In case the institution is running more than one teacher education programme, it is required to submit staff list duly approved by the Affiliating body for each of the recognised teacher education programme being run by the Institution.)

8. The institution has not submitted original FDRs to the SRC, NCTE. The institution is required to submit a "Form A" issued by the respective Bank Manager towards creation of FDR of Rs.7 lakh and 5 lakh, totalling Rs.12 lakh towards Endowment Fund & Reserve Fund into joint account for a duration of 5 years along with a copy of the FDRs
9. Details of Teacher Education programme (s) being run by the Institution in the same campus

Therefore, the Committee decided to issue Final Show Cause Notice u/s 17 of NCTE Act, 1993 before withdrawal of the recognition on the grounds mentioned above to the institution. The institution is required to submit the documents within 21 days from the date of issue of Final Show Cause Notice."

Now therefore, in compliance of the decision of the SRC this final show cause notice is issued u/s 17 (1) of NCTE Act, 1993 with the direction to submit your written representation within a period of 21 days from the date of issue of this notice, complying the decision of the SRC, failing which action u/s 17(1) will be taken as per NCTE Act & Regulations 2014.

You are also directed that if any document is in regional language, the Notarized English translation be also submitted.

In case, the office does not receive any representation within the stipulated time, it will be presumed that the institution does not wish to make any representation, and the Southern Regional Committee shall take decision as per provisions of the NCTE Act and Regulations.
