FINAL SHOW CAUSE NOTICE U/S 17

WHEREAS, recognition was granted to the institution namely Shree Swami Narayana Gurukul College of Education, Yenkanapally Post, Monabad Mandal, Rangareddy, Hyderabad-500075, Andhra Pradesh run by Shree Swami Narayana Gurukul Trust, Hyderabad, Andhra Pradesh vide SRC (NCTE) order no. F.SRO/NCTE/B.Ed/2006-2007/5851 dt. 29.06.2007 for conducting B.Ed course of one year duration with an annual intake of 100 students.

- **2.** AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution is submitted affidavit dt 28.03.2015 for its willingness for adherence of provisions of new Regulations.
- **3. AND WHEREAS,** a Revised Provisional Recognition Order was issued to the institution on 02.07.2015 for conducting B.Ed course of two years duration with an annual intake of 100 (Two basic units) from the academic session 2015-16.
- **4. AND WHEREAS,** the FDRs in original were returned to the institution vide letter dt. 21.06.2016. The SRC in its 369th meeting held on 28.01.2019 and the Committee decided that Show Cause Notice be issued to all such institutions which have not submitted compliance.
- **5. AND WHEREAS,** as per the decision of SRC, a show cause notice was issued to the institution on 07.03.2019. The institution vide letter dated 05.04.2019 submitted its reply to the show cause notice. The SRC in its 377^{th} meeting held on $03^{rd} 04^{th}$ July, 2019 considered the matter and decided as under;

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

- The institution has not submitted a certified copy of land documents. The institution is required to submit certified copy of land documents issued by concerned Tahsildar /Revenue Officer. (If the same are in Regional Language the institution is also required to submit notarised copy of English version of land documents)
- 2. The institution has not submitted a copy of Land Use Certificate. The institution is required to submit an attested/notarised copy of Land Use Certificate issued by the Competent Authority.
- The institution has not submitted a copy of Non Encumbrance Certificate issued by the Competent Authority. The institution is required to submit a attested/notarised copy of Non Encumbrance Certificate issued by the Competent Authority.

- 7. NOW, THEREFORE, the institution is required to submit the representation/compliance accompanied with an affidavit from the authorized representation of the Management. The representation along with an affidavit must reach this office within the time specified at the end.
- 8. In case the reply submitted is incomplete of factually incorrect of not received in this office by the date mentioned at the end of this letter, then proceedings under Section 17(1) of the NCTE Act shall be brought to logical conclusion without any further opportunity provided in the matter whatsoever.
- 9. It is expected that your reply shall reach this office through Courier/Registered AD/ Speed Post only. NCTE does not expect applicants to personally visit the RC Office for any reason whatsoever.
- 10. Your reply, complete in all respects must reach this office <u>within 21 days</u> of the issue of this **Final Show Cause Notice.**
