WHEREAS, recognition was granted to the institution namely Ravoof & Vazir Khans Memorial College of Education, S.No.278/3, P.No.67-83, Chapuram Panchayat, Srikakulam District, Andhra Pradesh run by Vazir Khan Memorial Educational Society, MIG-27, Opp. Electrical Revenue Office, Srikakulam - 532001, Andhra Pradesh vide SRC (NCTE) order no. F.SRO/NCTE/B.Ed/2007-2008/13590 dt. 26.10.2007 for conducting B.Ed. course of one-year duration with an annual intake of 100 students from the academic session 2007-2008.

AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution is submitted affidavit dt 19.01.2015 for its willingness for adherence of provisions of new Regulations.

AND WHEREAS, a Revised Provisional Recognition Order was issued to the institution on 06.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 (Two basic units) from the academic session 2015-16.

AND WHEREAS, subsequently the SRC issued Corrigendum F.SRO/NCTE/APSO7944/B.Ed/AP/2015/68061 dated 22.06.2015 permitting the institution to have one basis unit of 50 students subject to the institution fulfilling following conditions namely:-

The Regional Committees shall arrange for verification of documents, inspection (i) of these premises and check adherence to these conditions by 20 Feb, 2016. If it is found by the Regional Committee that the institution fails to comply with these requirements, the institutions shall not be permitted to admit students for the academic year 2016-2017.

AND WHEREAS, the SRC in its 368th meeting held on 08th - 09th January, 2019 considered and decided as under: -

- 1. We issued SCNs to this college on 06.05.2015 and 22.06.20015 listing various conditions for compliance.
- 2. They have submitted only some FDRs.
- 3. Issue SCN for withdrawal of recognition.
- 4. Put up in the 370th meeting.

AND WHEREAS, as per the decision of SRC a show cause notice was issued to the institution on 18.01.2019. The institution vide letter dated 30.01.2019 and 13.02.2019 submitted reply to

the show cause notice. The SRC in its 373<sup>rd</sup> meeting held on 26<sup>th</sup> – 27<sup>th</sup> March, 2019 considered and decided as under:-

The original files of the institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC. The Committee noted that the institution has requested for reduction of intake from 2 unit to 1 unit and the following observations were made:-

- The institution is required to submit certified copy of land documents.
   (If the same are in Regional Language the institution is also required to submit notarised copy of English version of land documents).
- A copy of the approved Building Plan (if institution is running more than one Teacher Education programme, it shall be required to submit an exclusive earmarked building plan for each of the recognised Teacher Education programme).
- Building Completion Certificate as per prescribed Format.
- Staff list duly approved by the affiliating body as per the prescribed Format.

Hence the Committee decided to issue SCN on the above points.

**AND WHEREAS,** as per the decision of SRC a show cause notice was issued to the institution on 08.04.2019. The institution vide letter dated 26.04.2019 submitted reply to the show cause notice. The SRC in its  $377^{th}$  meeting held on  $03^{rd} - 04^{th}$  July, 2019 considered and decided as under:-

The original files of the institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

- 1. Certified copy of the land documents not submitted by the institution.
- 2. The institution has not submitted a copy of approved building plan.
- Fine Arts, Performing Arts and Physical Education teachers are not appointed by the institution. The institution has not submitted a copy of the educational certificate of all the faculty. It has not submitted experience certificate of the Principle.

The Committee decided to <u>withdraw the recognition</u> granted to the institution for conducting B.Ed course under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above.

NOW, THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition of Ravoof & Vazir Khans Memorial College of Education, S.No.278/3, P.No.67-83, chapuram Panchayat, Srikakulam District, Andhra Pradesh run by Vazir Khan Memorial Educational Society, MIG-27, Opp. Electrical Revenue Office, Srikakulam – 532001, Andhra Pradesh for conducting B.Ed programme of two years duration with an annual intake of 50 students (1 unit) which were finally allowed to the Institution vide Corrigendum order No. F.SRO/NCTE/APSO7944/B.Ed/AP/2015/68061 dated 22.06.2015 on the grounds mentioned above.

Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website <a href="https://www.ncte-india.org">www.ncte-india.org</a> within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
