Final show cause notice u/s 17 of the NCTE, 1993

Whereas, the institution namely Dr. S.N.S. College of Education, No.487, Thudiyalur-Sarvanampatti Road, Coimbatore-641006, Tamilnadu was granted recognition for conducting B.Ed. course of one year' duration with an annual intake of 100 students from the academic session 2006-2007 vide SRC, NCTE's order no. F.SRO/NCTE/B.Ed./2006-2007/15317 dt.28.11.2007.

And whereas, a provisional revised recognition order dt. 30.04.2015 was issued to the institution for conducting B.Ed. course of two years' duration with an annual intake of 100 (two basic units) from the academic session 2015-16 subject to the following conditions:-

- (i) The institution shall submit revalidated FDRs of the enhanced values, in joint account with the SRC before 30th June, 2015 failing which the recognition will be withdrawn.
- (ii) The institution shall create additional facilities that include (a) additional built-up area, (b) additional infrastructure, (c) additional staff as per Regulations, 2014 and inform Regional Committees with required documents by October 31, 2015.
- (iii) The applicant-institution for additional unit will be required to submit the required documents such as land documents, Encumbrance Certificate (EC), Land Use Certificate (LUC), Building Plan (BP) and the Approved Staff List in the specified proforma available on the website to the Regional Committee in proof of having provided additional facilities before October 31, 2015. Building Completion Certificate (BCC) may be given along with other documents if available, otherwise it can also be given to the Visiting Team at the time of inspection.
- (iv) The Regional Committees shall arrange for verification of documents, inspection of these premises and check adherence to these conditions by 20 Feb, 2016. If it is found by the Regional Committee that the institution fails to comply with these requirements, the institutions shall not be permitted to admit students for the academic year 2016-2017.

And whereas, the institution has submitted its compliance, for conditions stipulated in provisional revised recognition order, vide *letters dt.04.03.2017 & dt.22.03.2018*.

And whereas, the *reply dt.04.03.2017 & dt.22.03.2018* of the institution along with regulatory file was placed before the SRC in its 377^{th} meeting held on $03^{rd} - 04^{th}$ July, 2019 and the Committee decided to issue final show cause notice u/s 17 (1) of the NCTE Act, 1993 on the following points:

"The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

- 1. The institution has not submitted a certified copy of land documents. The institution is required to submit certified copy of land documents issued by concerned Tehsildar /Revenue Officer. - 2. The institution has not submitted a copy of Land Use Certificate. The institution is required to submit an attested/notarised copy of Land Use Certificate issued by the Competent Authority.
- 3. The institution has not submitted a copy of Non Encumbrance Certificate issued by the Competent Authority. The institution is required to submit a attested/notarised copy of Non Encumbrance Certificate issued by the Competent Authority.
- 4. The institution has not submitted a copy of approved building plan. The institution is required to submit a attested/notarised copy of the approved Building Plan (if institution is running more than one Teacher Education programme, it shall be required to submit an exclusive earmarked building plan for each of the recognised Teacher Education programme)
- 5. A attested/notarised copy of site plan showing all the plot/Survey No. mentioned in the land documents in one location along with land area and built up area.
- 6. The institution has not submitted a copy of Building Completion Certificate. The Institution is required to submit an attested/notarised copy of Building Completion Certificate issued by the competent authority.
- 7. The institution has not submitted Staff list as per the prescribed Format duly approved by Registrar of the affiliating body. The institution is required to submit Staff list duly approved by the Registrar of the affiliating body as per the prescribed Format. (In case the institution is running more than one teacher education programme, it is required to submit staff list duly approved by the Affiliating body for each of the recognised teacher education programme being run by the Institution.)
- 8. The institution has not submitted original FDRs to the SRC, NCTE The institution is required to submit a "Form A" issued by the respective Bank Manger towards creation of FDR of Rs.7 lakh and 5 lakh, totalling Rs.12 lakh towards Endowment Fund & Reserve Fund into joint account for a duration of 5 years alogwith a copy of the FDRs
- 9. Details of Teacher Education programme (s) being run by the Institution in the same campus

Therefore, the Committee decided to issue Final Show Cause Notice u/s 17 of NCTE Act, 1993 before withdrawal of the recognition on the grounds mentioned above to the institution. The institution is required to submit the documents within 21 days from the date of issue of Final Show Cause Notice.

Now therefore, in compliance of the decision of the SRC this final show cause notice (SCN) is issued u/s 17 (1) of NCTE Act, 1993 with the direction to submit your written representation within a period of 21 days from the date of issue of this notice, complying the decision of the SRC, failing which action u/s 17(1) will be taken as per NCTE Act & Regulations 2014.

You are also directed that if any document is in regional language, the Notarized English translation be also submitted.

In case, the office does not receive any representation within the stipulated time, it will be presumed that the institution does not wish to make any representation, and the Southern Regional Committee shall take decision as per provisions of the NCTE Act and Regulations.
