MINUTES OF THE 296th MEETING

Since Prof. Chandrashekhar Vazalwar, Chairperson, WRC, NCTE has expressed his inability to attend this meeting, the members of the committee unanimously decided to conduct the meeting under Chairmanship of Dr. Louis Vernal.

Shri L.S. Baghel, Member and the State Representatives of Maharashtra, Gujarat, Chhattisgarh, Daman & Diu and Dadra & Nagar Haveli did not give any information about their presence.

At the outset, Shri Awadhesh Nayak, Regional Director (I/C) and Convener, welcomed the Chairperson and all the members of WRC, NCTE to the 296th meeting of the WRC.

The Regional Director, being Convener of the WRC, presented each agenda item for consideration of the WRC.

Agenda 296.3 : Policy decisions/letters received from NCTE Hqrs.

WRC considered the two communications No.68759 dated 02.08.2018 and No.68987 dated 13.08.2018 received from NCTE Hqrs regarding issues relating to Revised Recognition Order. It would like to reiterate that it may be necessary to consider affidavit and the requirement of NET/SET at the same time. NET/SET is a requirement of UGC which has been upheld by the Hon'ble Supreme Court. As far as NCTE is concerned, the effective date is 09.06.2017. In the course of dealing with affidavits, the staff appointed after 09.06.2017 should have NET/SET. The WRC has been following this procedure.

Accordingly, the WRC decided to issue Show Cause Notices to institutions which appointed staff without Ph.D. or NET/SET after the issue of LOI post NCTE notification published on 09.06.2017.
