Prof. Freny Tarapore, Members, WRC; expressed their inability to attend the meeting. Dr. Shobha Khandare and Dr. T.S. Joshi, State Representatives of Maharashtra and Gujarat expressed their inability to attend the meeting. The Representatives of States/UTs of Daman & Diu and Dadra & Nagar Haveli could not attend the meeting.

At the outset, Shri Satish Gupta, Regional Director and Convener, welcomed the Chairperson and all the members of WRC, NCTE to the 255th meeting of the WRC.

The Regional Director, being Convener of the WRC, presented each agenda item for consideration of the WRC.

The agenda were taken up as follows:-

255.1 Confirmation of the minutes of 254th Meeting of WRC

The minutes of 254th meeting were confirmed by the Committee with the following amendment in Case No. APW05498/223585 - Swami Vivekanand Shiksha College, Morena, Madhya Pradesh :- "The WRC therefore decided to issue Show Cause Notice for reducing the intake to one unit of B.Ed. instead of the present two units, from the academic session 2016-2017."

255.2 Action Taken Report of 254th Meeting of WRC

The WRC took note of the Action Taken Reports.



255.3 Policy decisions/letters received from NCTE Hqrs. /State Government.

The letter received from NCTE Hqrs. dt. 17/05/2016 was discussed in the WRC. The Committee advised the Regional Director to prepare and implement a programme for monitoring as advised in this letter.

However, as regards the advice contained in Para 3, the WRC requested the Regional Director to seek clarification from NCTE whether the WRC could authorize inspections for monitoring purposes, since this is not provided for in the NCTE Act/NCTE Regulations.

The WRC feels that any instructions / guidelines which directly affect the TEIs should be put on the website of the NCTE for their information.

Letter dt. 26/05/2016 - The Regional Director has put up suggestions for amendment. These were discussed in the meeting and appropriate direction regarding each suggestion was given, for sending onwards to the NCTE Hqrs.

Letter dt. 31/05/2016 - The WRC took note.

Letter dt. 09/06/2016 - The Regional Director informed that he has taken action.
