## <u>Instructions and procedure for filling online application for transition from 4-year Integrated Programme</u> (B.A. B.Ed/B.Sc. B.Ed) to ITEP

The applicant institutions are requested to read the following instructions carefully, before filling online application: -

- The National Council for Teacher Education (Recognition Norms and Procedures) Amendment Regulations, 2021 published in the Gazette of India, Extraordinary, Part III, Section 4, *vide* Notification No. NCTE-Regl011/80/2018-MS(Regulation)-HQ, dated the 26<sup>th</sup> October, 2021 and F.No. NCTE-Regl.022/05/2021-O/o DS(Regulation)-HQ, dated the 19<sup>th</sup> October 2022 and F.No. NCTE-Regl.022/16/2023-Reg.Sec.-HQ, dated the 30<sup>th</sup> January 2024
- Public Notice dated 05.02.2024 for Transition from 4-year Integrated Programme (B.A. B.Ed./B.Sc. B.Ed.) to ITEP.

- The web link to fill up online application will remain active from **05.02.2024 to 05.03.2024 (till 11:59 p.m.)**. Institutions are advised to fill the online application well in time/advance, without waiting for the last date of applying to avoid any network congestion/hassle. NCTE will not be responsible for any inconvenience caused due to network error.
- Applicant institutions are advised to fill the correct and complete details, as this information shall be recorded and shall be used for further evaluation, communication, reference and final decision on transition to ITEP.
- Applicant institutions are advised to keep all relevant documents (including Society/Trust/Company Registration Certificate (If applicable), copy/copies of NOC of affiliating body (If applicable), Land Details Certificate, Building Completion Certificate and Staff approval from the affiliating University etc. ready before filling the online application.
